

BEARD PARCEL (Map No. 99-199)

A parcel of land being Lots 7 and 8, and other lands in the "RE-SURVEY OF LOTS 5-6-7-8, PLAT OF MINOCQUA HEIGHTS, GOLF AND COUNTRY CLUB ADD", recorded in Volume 5 of Plats, on page 27, located in Government Lot 3, Section 13, Township 39 North, Range 6 East, Minocqua Township, Oneida County, Wisconsin, being the "BEARD" parcel shown on Map No 99—199 by Wilderness Surveying, Inc , dated October 18th, 1999, more particularly described as
