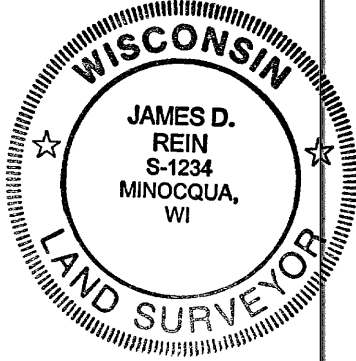

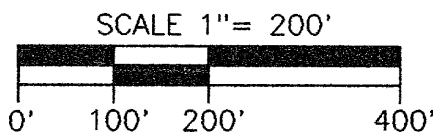

A parcel of land previously described in Volume 249, on page 162 located in the Southwest Quarter of the Southeast Quarter, Section 24, Township 37 North, Range 6 East, Cassian Township, Oneida County, Wisconsin, being TAX PCL. No. CA 368-1, shown on Map No. 00-247 by Wilderness Surveying, Inc. dated January 15, 2001, more particularly described as follows:

Commencing at the southwest corner of the Southwest Quarter of the Southeast Quarter, being the south quarter corner of Section 24, marked by a capped aluminum monument, thence North 00 degrees 31 minutes 35 seconds East for a distance of 1317.20 feet to the northwest corner of the Southwest Quarter of the Southeast Quarter, being the Center-South Sixteenth Corner, marked by an aluminum capped iron pipe, thence North 89 degrees 08 minutes 40 seconds East for a distance of 649.04 feet along the north line of the Southwest Quarter of the Southeast Quarter to the place of beginning, being the northeast corner of that parcel of land described in Volume 895, on pages 519 and 520, marked by an iron pipe.

Thence continuing North 89 degrees 08 minutes 40 seconds East for a distance of 627.11 feet along the north line of the Southwest Quarter of the Southeast Quarter, to an iron pipe on the westerly right of way line of Lakewood Road, thence South 00 degrees 13 minutes 51 seconds West for a distance of 330.00 feet along said westerly right of way line to an iron pipe on the northerly line of that parcel of land described in Volume 897, on page 49, thence South 89 degrees 08 minutes 40 seconds West for a distance of 627.11 feet along the northerly line of said parcel of land described in Volume 897, on page 49 to the east line of that parcel of land described in Volume 895, on pages 519 and 520, marked by an iron pipe, thence North 00 degrees 13 minutes 51 seconds East for a distance of 330.00 feet along the east line of said parcel of land described in Volume 895, on pages 519 and 520 to the place of beginning.

Beginning at the southwest corner of the Southwest Quarter of the Southeast Quarter, being the south quarter corner of Section 24, marked by a capped aluminum monument, thence North 00 degrees 31 minutes 35 seconds East for a distance of 1317.20 feet to the northwest corner of the Southwest Quarter of the Southeast Quarter, being the Center-South Sixteenth Corner, marked by an aluminum capped iron pipe, thence North 89 degrees 08 minutes 40 seconds East for a distance of 649.04 feet along the north line of the Southwest Quarter of the Southeast Quarter to the northwest corner of that parcel of land described in Volume 249, on page 162, marked by an iron pipe, thence South 00 degrees 13 minutes 51 seconds West for a distance of 987.49 feet along the westerly lines of those parcels of land described in Volume 249, on page 162 and Volume 897, on page 49 to intersect the northerly line of that parcel of land described in Volume 280, on page 169, marked by an iron pipe, thence South 89 degrees 11 minutes 00 seconds West for a distance of 32.90 feet to the northwest corner of said parcel of land described in Volume 280, on page 169, marked by an iron pipe, thence South 00 degrees 13 minutes 51 seconds West for a distance of 330.00 feet along the westerly line of said parcel of land described in Volume 280, on page 169, to an iron pipe on the south line of the Southwest Quarter of the Southeast Quarter, thence South 89 degrees 11 minutes 00 seconds West for a distance of 622.94 feet along the south line of the Southwest Quarter of the Southeast Quarter to the place of beginning.
