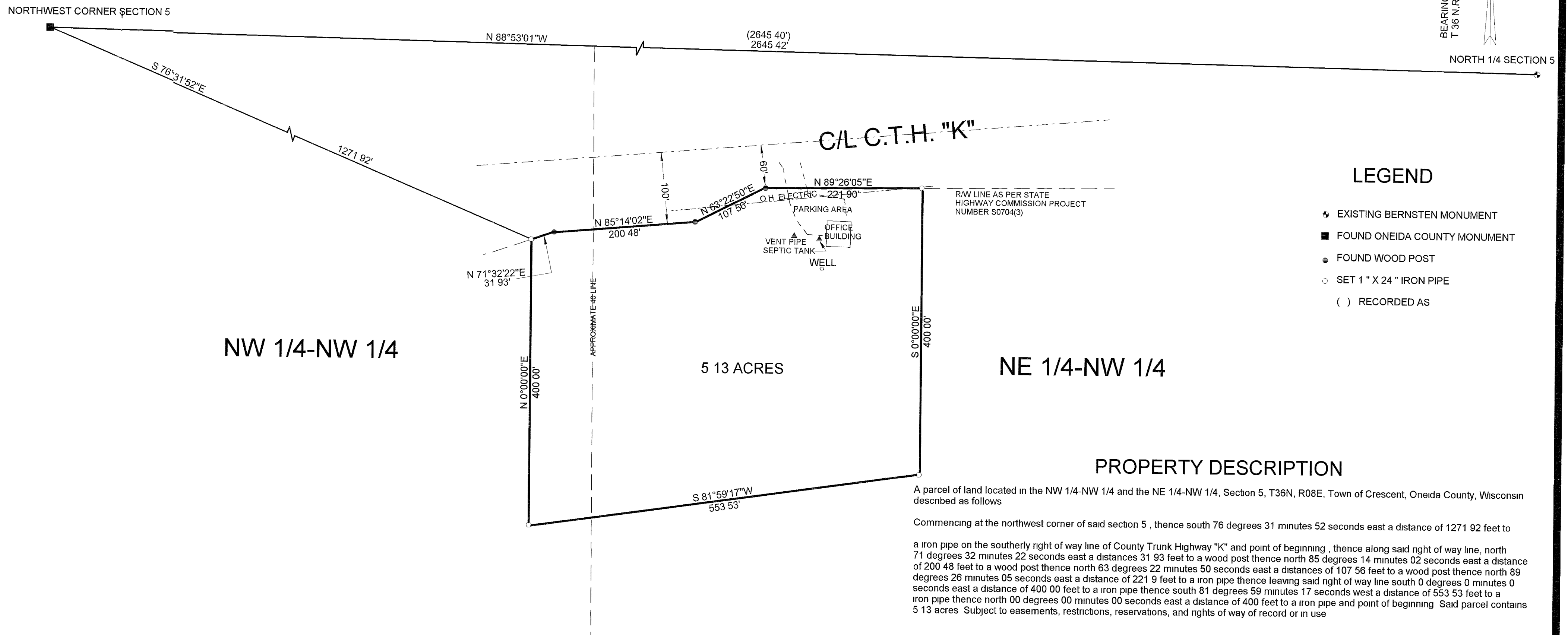

PROPERTY DESCRIPTION

A parcel of land located in the NW 1/4-NW 1/4 and the NE 1/4-NW 1/4, Section 5, T36N, R08E, Town of Crescent, Oneida County, Wisconsin described as follows

Commencing at the northwest corner of said section 5, thence south 76 degrees 31 minutes 52 seconds east a distance of 1271 92 feet to a iron pipe on the southerly right of way line of County Trunk Highway "K" and point of beginning, thence along said right of way line, north 71 degrees 32 minutes 22 seconds east a distance of 31 93 feet to a wood post thence north 85 degrees 14 minutes 02 seconds east a distance of 200 48 feet to a wood post thence north 63 degrees 22 minutes 50 seconds east a distance of 107 56 feet to a wood post thence north 89 degrees 26 minutes 05 seconds east a distance of 221 9 feet to a iron pipe thence leaving said right of way line south 0 degrees 0 minutes 0 seconds east a distance of 400 00 feet to a iron pipe thence south 81 degrees 59 minutes 17 seconds west a distance of 553 53 feet to a iron pipe thence north 00 degrees 00 minutes 00 seconds east a distance of 400 feet to a iron pipe and point of beginning.
