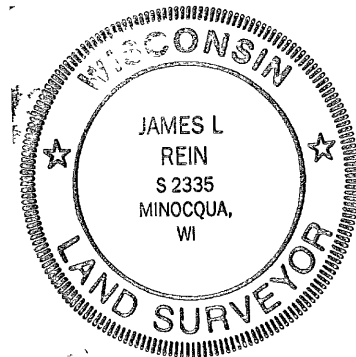

ANDERSON PARCEL (Map No 01-115)

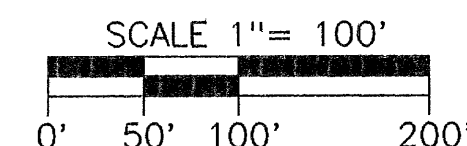
A parcel of land previously described in Volume 947, on pages 723 and 724, located in Outlot 7 of the original Plat of the VILLAGE OF HAZELHURST, in Government Lot 6, Section 3, Township 38 North, Range 6 East, Hazelhurst Township, Oneida County, Wisconsin, being the "ANDERSON" parcel as shown on Map No 01-115 by Wilderness Surveying, Inc., dated October 3, 2001, more particularly described as follows

Commencing at the south quarter corner of Section 3, marked by a cast aluminum monument, thence North 23 degrees 31 minutes 50 seconds East for a distance of 972.54 feet to the place of beginning, marked by an iron pipe on the easterly right of way line of U.S. Highway "51"

Thence along said easterly right of way line of U.S. Highway "51", North 13 degrees 46 minutes 14 seconds West for a distance of 189.44 feet to an intersection with the southerly right of way line of Yawkey Street, marked by an iron pipe, thence along the southerly right of way line of Yawkey Street, South 85 degrees 36 minutes 11 seconds East for a distance of 184.02 feet to an iron pipe, thence South 04 degrees 23 minutes 49 seconds West for a distance of 180.00 feet to an iron pipe, thence North 85 degrees 36 minutes 11 seconds West for a distance of 124.95 feet to the place of beginning

Together with and subject to covenants, easements, and restrictions of record.

Said property contains 0.64 acres

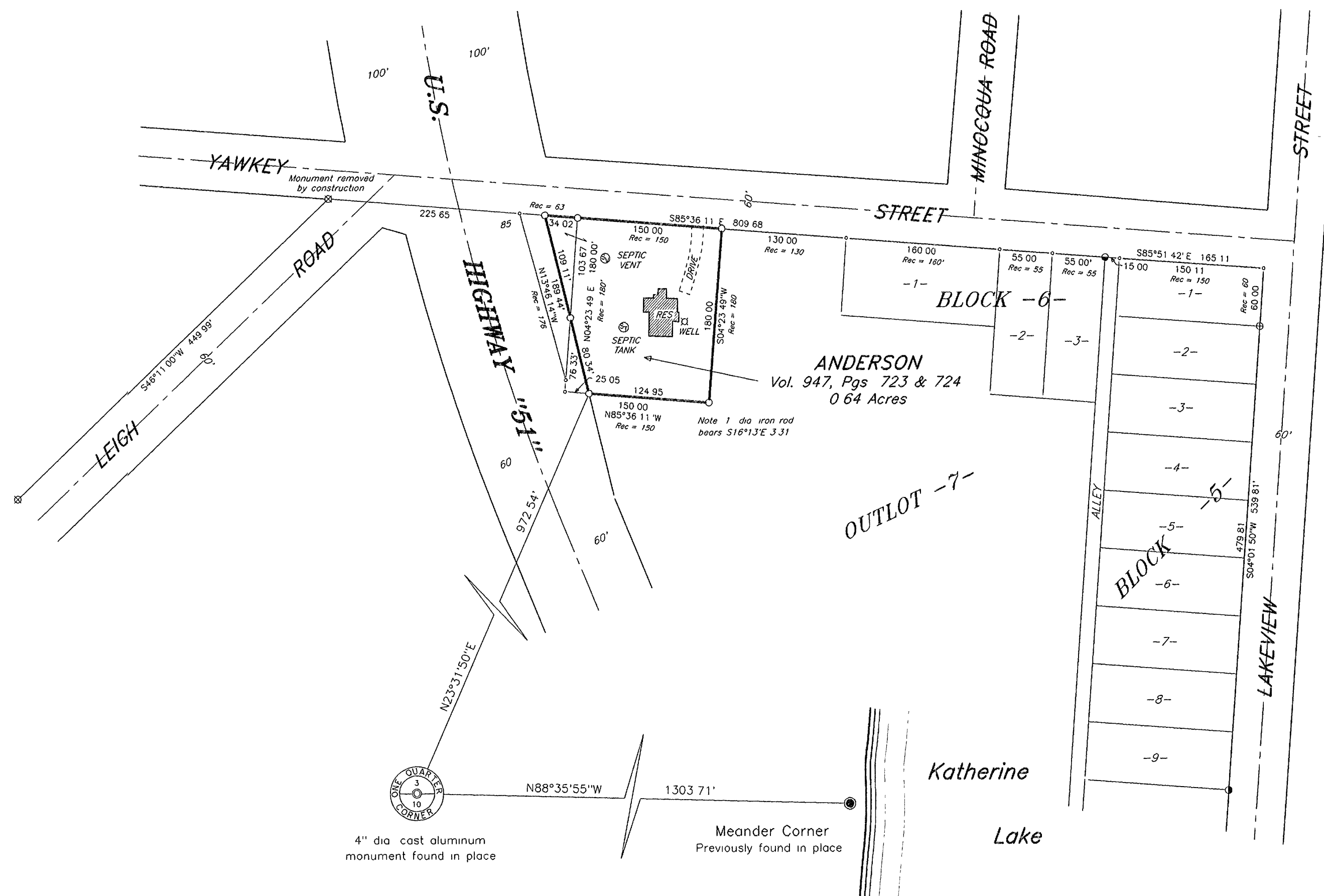


LEGEND
