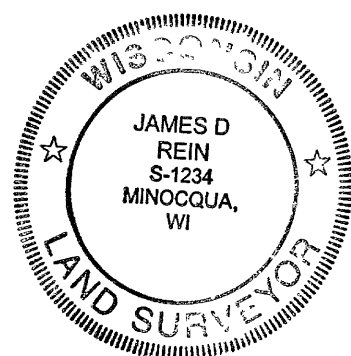

PARCEL -A- (Map No. 95-153A)

A parcel of land in Government Lot 1, Section 33 Township 39 North, Range 10 East Sugar Camp Township, Oneida County, Wisconsin, being parcel "A" shown on Map No. 95-153A by Wilderness Surveying, Inc., dated December 28, 2001, more particularly described as follows:

Commencing at the Meander Corner where the north line of said Section 33 intersects the easterly shore of Columbus Lake, marked by a capped aluminum monument, thence meandering along the lake South 43 degrees 25 minutes 20 seconds West for a distance of 100.04 feet to an iron pipe, thence continuing along the lake South 42 degrees 57 minutes 40 seconds West for a distance of 100.20 feet to an iron pipe, thence continuing along the lake South 33 degrees 02 minutes 22 seconds West for a distance of 99.80 feet to the place of beginning, marked by an iron pipe on the southerly line of that parcel of land described in Volume 358 on page 609.

Thence continuing along the lake South 49 degrees 33 minutes 42 seconds West for a distance of 150.03 feet to an iron pipe on the northerly line of NEPTUNE'S RESORT, a Condominium, thence along said northerly line of NEPTUNE'S RESORT a Condominium South 51 degrees 17 minutes 33 seconds East for a distance of 365.00 feet to an iron pipe, thence continuing along said northerly line South 72 degrees 20 minutes 59 seconds East for a distance of 159.52 feet to an iron pipe, thence continuing along said northerly line South 51 degrees 17 minutes 33 seconds East for a distance of 290.00 feet to an iron pipe on the westerly right of way line of Columbus Lake Road, thence along said right of way line, along a curve to the right, having a radius of 742.37 feet and an arc length of 49.09 feet, being subtended by a chord of North 40 degrees 53 minutes 05 seconds East for a distance of 49.08 feet to an iron pipe, thence continuing along said right of way line North 42 degrees 46 minutes 45 seconds East for a distance of 41.08 feet to an iron pipe on the southerly line of that parcel of land described in Volume 358 on page 609, thence North 51 degrees 17 minutes 33 seconds West for a distance of 780.40 feet along the southerly line of said parcel of land to the place of beginning.

The above lateral lot lines extend to Columbus Lake and include all lands lying between the meander line and the ordinary high water mark.

Said property contains 2.26 acres, more or less.

A parcel of land partially described in Volume 358 on page 609 located in Government Lot 1 Section 33 Township 39 North Range 10 East Sugar Camp Township Oneida County Wisconsin, being the "ANTANAITIS" parcel shown on Map No. 95-153A by Wilderness Surveying, Inc. dated December 28, 2001 more particularly described as follows:

Commencing at the Meander Corner where the north line of said Section 33 intersects the easterly shore of Columbus Lake, marked by a capped aluminum monument, thence meandering along the lake South 43 degrees 25 minutes 20 seconds West for a distance of 100.04 feet to an iron pipe, thence continuing along the lake South 42 degrees 57 minutes 40 seconds West for a distance of 100.20 feet to the place of beginning, marked by an iron pipe.

Thence continuing along the lake South 33 degrees 02 minutes 22 seconds West for a distance of 99.80 feet to an iron pipe, thence South 51 degrees 17 minutes 33 seconds East for a distance of 780.40 feet to an iron pipe on the westerly right of way line of Columbus Lake Road, thence along said right of way line North 42 degrees 46 minutes 45 seconds East for a distance of 99.86 feet to an iron pipe, thence North 51 degrees 18 minutes 50 seconds West for a distance of 797.34 feet to the place of beginning.

The above lateral lot lines extend to Columbus Lake, and include all lands lying between the meander line and the ordinary high water mark.
