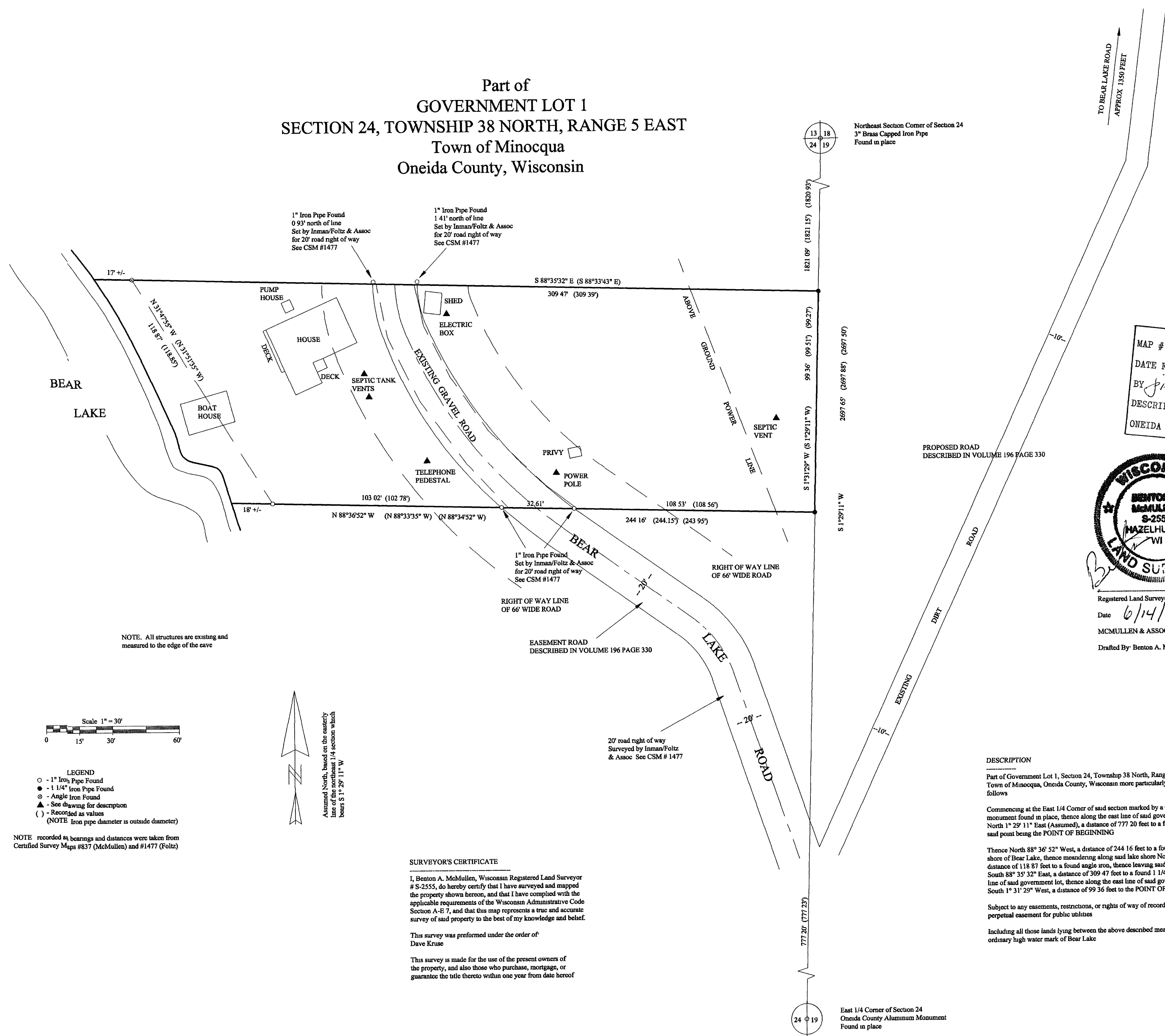


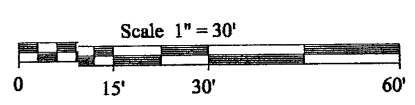

Assumed North, based on the easterly line of the northeast 1/4 section which bears S 1° 29' 11" W

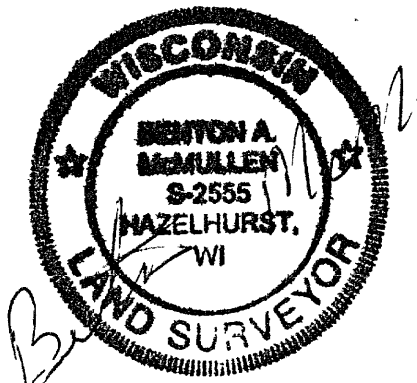

DESCRIPTION

Part of Government Lot 1, Section 24, Township 38 North, Range 5 East, Town of Minocqua, Oneida County, Wisconsin more particularly described as follows

Commencing at the East 1/4 Corner of said section marked by a Oneida County Aluminum monument found in place, thence along the east line of said government lot North 1° 29' 11" East (Assumed), a distance of 777.20 feet to a found 1 1/4" iron pipe, said point being the POINT OF BEGINNING

Thence North 88° 36' 52" West, a distance of 244.16 feet to a found 1" iron pipe near the shore of Bear Lake, thence meandering along said lake shore North 31° 47' 55" West, a distance of 118.87 feet to a found angle iron, thence leaving said lake shore South 88° 35' 32" East, a distance of 309.47 feet to a found 1 1/4" iron pipe on the east line of said government lot, thence along the east line of said government lot South 1° 31' 29" West, a distance of 99.36 feet to the POINT OF BEGINNING

Subject to any easements, restrictions, or rights of way of record or of use, and to a perpetual easement for public utilities

Including all those lands lying between the above described meander line and the ordinary high water mark of Bear Lake
