

That parcel of land previously described in Document No 382338 located in Government Lot 2 Section 10 Township 38 North Range 6 East Hazelhurst Township Oneida County Wisconsin being the RAYMOND' parcel shown on Map No 02-115 by Wilderness Surveying Inc. dated August 30 2002 more particularly described as follows

Commencing at the north quarter corner of Section 10 marked by a cast aluminum monument thence South 32 degrees 32 minutes 56 seconds East for a distance of 2039 03 feet to the place of beginning marked by an iron pipe on the easterly right of way line of U.S. Highway 51

Thence South 88 degrees 15 minutes 18 seconds East for a distance of 897 56 feet to an iron pipe near the westerly shore of Katherine Lake thence meandering along the lake South 24 degrees 23 minutes 12 seconds East for a distance of 219 52 feet to an iron pipe thence North 88 degrees 23 minutes 05 seconds West for a distance of 941 58 feet to an iron pipe on the easterly right of way line of U.S. Highway 51' thence along said right of way line along a curve to the right, having a radius of 1758 24 feet and an arc length of 194 74 feet, being subtended by a chord of North 13 degrees 14 minutes 22 seconds West for a distance of 194 64 feet to an iron pipe thence continuing along said right of way line North 10 degrees 03 minutes 59 seconds West for a distance of 11 43 feet to the place of beginning

The above lateral lot lines extend to Katherine Lake and include all lands lying between the meander line and the ordinary high water mark
