

## Parcel 9 (Map No 02-144)

A parcel of land in Government Lot 8, Section 19, Township 36 North, Range 8 East, Crescent Township, Oneida County, Wisconsin, being parcel "9" shown on Map No 02-144 by Wilderness Surveying, Inc., dated October 16, 2002, more particularly described as follows

Commencing at the west quarter corner of Section 19, marked by a brass capped concrete monument, thence North 75 degrees 03 minutes 03 seconds East for a distance of 1381.38 feet to the place of beginning, marked by an iron pipe on the easterly right of way line of Long Lake Road

Thence along said right of way line, North 47 degrees 02 minutes 36 seconds West for a distance of 64.24 feet to iron pipe, thence North 67 degrees 45 minutes 22 seconds East for a distance of 499.91 feet to an iron pipe near the westerly shore of Squash Lake, thence meandering along the lake South 18 degrees 57 minutes 07 seconds East for a distance of 100.42 feet to an iron pipe, thence South 72 degrees 53 minutes 09 seconds West for a distance of 469.07 feet to the place of beginning

The above lateral lot lines extend to Squash Lake, and include all lands lying between the meander line and the ordinary high water mark

Commencing at the west quarter corner of Section 19, marked by a brass capped concrete monument, thence North 75 degrees 03 minutes 03 seconds East for a distance of 1381.38 feet to an iron pipe on the easterly right of way line of Long Lake Road, thence along said right of way line, North 47 degrees 02 minutes 36 seconds West for a distance of 64.24 feet to the place of beginning, marked by an iron pipe

Thence continuing along said right of way line, North 46 degrees 05 minutes 20 seconds West for a distance of 32.81 feet to an iron pipe, thence continuing along said right of way line, North 48 degrees 11 minutes 29 seconds West for a distance of 37.39 feet to an iron pipe, thence North 64 degrees 21 minutes 19 seconds East for a distance of 541.54 feet to an iron pipe near the westerly shore of Squash Lake, thence meandering along the lake South 11 degrees 36 minutes 50 seconds East for a distance of 23.39 feet to an iron pipe, thence continuing along the lake South 16 degrees 56 minutes 54 seconds East for a distance of 73.07 feet to an iron pipe, thence South 67 degrees 45 minutes 22 seconds West for a distance of 499.91 feet to the place of beginning

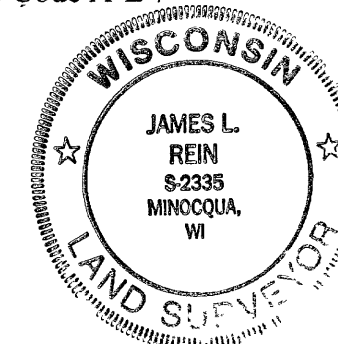

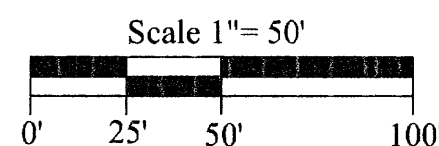
