



Commencing at the northwest corner of Section 7, marked by a P.K. Nail in the pavement of County Highway "J"; thence South 86 degrees 21 minutes 52 seconds East for a distance of 1142.63 feet to the northeast corner of the Northwest Quarter of the Northwest Quarter, being the West Sixteenth Corner, in the pavement of said County Highway "J"; thence South 00 degrees 52 minutes 12 seconds East for a distance of 33.05 feet along the east line of the Northwest Quarter of the Northwest Quarter to an iron pipe on the southerly right of way line of said County Highway "J"; thence along said right of way line North 86 degrees 22 minutes 04 seconds West for a distance of 515.00 feet to the place of beginning, marked by an iron pipe.

Thence South 00 degrees 52 minutes 14 seconds East for a distance of 416.89 feet to an iron pipe; thence South 87 degrees 02 minutes 02 seconds East for a distance of 199.83 feet to an iron pipe; thence South 00 degrees 52 minutes 13 seconds East for a distance of 33.07 feet to an iron pipe on the northerly line of that parcel of land described in Volume 601, on pages 567 & 568; thence along said northerly line North 87 degrees 02 minutes 02 seconds West for a distance of 530.91 feet to the southeast corner of Lot 5 in the County Plat of EARLS PARK, marked by an iron pipe; thence North 00 degrees 20 minutes 47 seconds West for a distance of 453.51 feet to the northeast corner of Lot 8 in said County Plat of EARLS PARK, marked by an iron pipe on the southerly right of way line of County Highway "J"; thence along said southerly right of way line South 86 degrees 22 minutes 04 seconds East for a distance of 327.20 feet to the place of beginning.



Thence South 00 degrees 52 minutes 13 seconds East for a distance of 414.56 feet to an iron pipe; thence North 87 degrees 02 minutes 02 seconds West for a distance of 199.83 feet to an iron pipe; thence North 00 degrees 52 minutes 14 seconds West for a distance of 416.89 feet to an iron pipe on the southerly right of way line of County Highway "J"; thence along said southerly right of way line South 86 degrees 22 minutes 04 seconds East for a distance of 200.00 feet to the place of beginning.
