

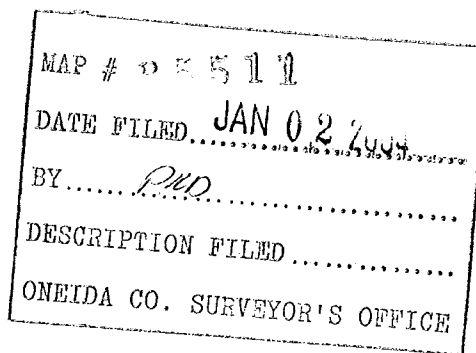

**Fraedrich Parcel (Map No. 03-211)**

That parcel of land previously described in Volume 745, on page 467, located in Government Lot 1, Section 31, Township 39 North, Range 5 East, Minocqua Township, Oneida County, Wisconsin, being the "Fraedrich" parcel shown on Map No. 03-211 by Wilderness Surveying, Inc., dated November 27, 2003, more particularly described as follows:

Commencing at the northwest corner of Section 31, marked by a brass capped iron pipe; thence South 00 degrees 18 minutes 08 seconds West for a distance of 1551.74 feet along the west line of Section 31 to the Meander Corner, marked by a concrete monument near the northerly shore of Pine Lake; thence South 80 degrees 46 minutes 42 seconds East for a distance of 1297.43 feet to the place of beginning, marked by an iron pipe near the northeasterly shore of Pine Lake.

Thence meandering along the lake South 65 degrees 48 minutes 29 seconds East for a distance of 75.00 feet; thence continuing along the lake South 41 degrees 33 minutes 27 seconds East for a distance of 75.00 feet to an iron pipe; thence North 87 degrees 15 minutes 23 seconds East for a distance of 203.34 feet to an iron pipe; thence North 01 degrees 22 minutes 33 seconds West for a distance of 507.24 feet to an iron pipe; thence North 89 degrees 59 minutes 20 seconds West for a distance of 295.91 feet to an iron pipe; thence South 01 degrees 45 minutes 20 seconds West for a distance of 430.23 feet to the place of beginning.

The above lateral lot lines extend to Pine Lake, and include all lands lying between the meander line and the ordinary high water mark.

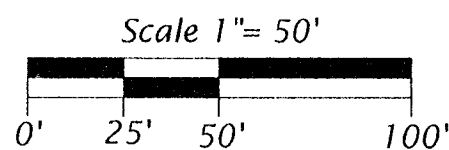
