

DESCRIPTION FOR PARCEL A

Part of Government Lot 5, Section 13, Township 39 North, Range 4 East, Town of Minocqua, Oneida County, Wisconsin more particularly described as follows:

Commencing at the West 1/4 Corner of said section marked by a found Oneida County aluminum monument, thence along the westerly line of said government lot North 0° 51' 38" East, a distance of 689.24 feet to a set 1 1/2" iron pipe, said point being the POINT OF BEGINNING.

Thence continuing northerly along said line, a distance of 100.00 feet to a found 1" iron pipe; thence leaving said government lot line South 89° 30' 43" East, a distance of 22.00 feet to a set 1 1/2" iron pipe near the shore of Great Bass Lake; thence meandering along said shore South 4° 17' 06" East, a distance of 100.35 feet to a set 1 1/2" iron pipe; thence leaving said shore North 89° 30' 43" West, a distance of 31.00 feet to the POINT OF BEGINNING.

Said described tract containing 0.11 acres (4703.77 square feet), more or less. This area includes some wet lands that could be considered lake bed.

Subject to any easements, restrictions, or rights of way of record or of use.

Including all those lands tying between the above described meander line and the water's edge of Great Bass Lake.

DESCRIPTION FOR PARCEL C (ACCESS EASEMENT)

Part of the Southeast 1/4 of the Northeast 1/4, Section 14, Township 39 North, Range 4 East, Town of Minocqua, Oneida County, Wisconsin more particularly described as follows:

Commencing at the East 1/4 Corner of said section marked by a found Oneida County aluminum monument, thence along the easterly line of said Southeast 1/4 of the Northeast 1/4 North 0° 51' 38" East, a distance of 193.88 feet to a set 1 1/2" iron pipe, said point being the POINT OF BEGINNING.

Thence South 74° 15' 16" West, a distance of 95.54 feet to the easterly right of way of Great Bass Lake Road marked by a set 1 1/2" iron pipe; thence along said right of way North 17° 53' 56" West, a distance of 66.05 feet to a set 1 1/2" iron pipe; thence leaving said right of way North 74° 15' 16" East, a distance of 117.70 feet to said easterly line of said Southeast 1/4 of the Northeast 1/4 marked by a set 1 1/2" iron pipe; thence along said easterly line South 0° 51' 38" West, a distance of 68.88 feet to the POINT OF BEGINNING.

Subject to any easements, restrictions, or rights of way of record or of use.

The above described easement parcel to be attached to those lands described as PARCEL B hereon this survey map.

DESCRIPTION FOR PARCEL B

Part of Government Lot 5, Section 13, Township 39 North, Range 4 East, Town of Minocqua, Oneida County, Wisconsin more particularly described as follows:

Commencing at the West 1/4 Corner of said section marked by a found Oneida County aluminum monument, said point being the POINT OF BEGINNING.

Thence along the westerly line of said government lot North 0° 51' 38" East, a distance of 689.24 feet to a set 1 1/2" iron pipe; thence leaving said government lot line South 89° 30' 43" East, a distance of 31.00 feet to a set 1 1/2" iron pipe near the shore of Great Bass Lake; thence meandering along said shore South 1° 15' 46" West, a distance of 177.72 feet; thence South 19° 00' 00" East, a distance of 360.00 feet; thence South 45° 00' 00" East, a distance of 220.00 feet to a found 2" iron pipe marking the southerly line of government lot 5; thence leaving said shore and along said southerly government lot line South 87° 10' 54" West, a distance of 310.58 feet to the POINT OF BEGINNING;

Said described tract containing 2.08 acres (90502.23 square feet), more or less. This area includes some wet lands that could be considered lake bed.

Subject to any easements, restrictions, or rights of way of record or of use.

With two access easements called PARCEL C and PARCEL D hereon this survey map.

Including all those lands lying between the above described meander line and the water's edge of Great Bass Lake.

DESCRIPTION FOR PARCEL D (ACCESS EASEMENT)

Part of the Southeast 1/4 of the Northeast 1/4, Section 14, Township 39 North, Range 4 East, Town of Minocqua, Oneida County, Wisconsin more particularly described as follows:

Commencing at the East 1/4 Corner of said section marked by a found Oneida County aluminum monument, thence along the easterly line of said Southeast 1/4 of the Northeast 1/4 North 0° 51′ 38" East, a distance of 20.00 feet to a set 1 1/2" iron pipe, said point being the POINT OF BEGINNING.

Thence North 90° 00' 00" West, a distance of 41.56 feet to the easterly right of way of Great Bass Lake Road marked by a set 1 1/2" iron pipe; thence along said right of way North 17° 53' 56" West, a distance of 69.36 feet to a set 1 1/2" iron pipe; thence leaving said right of way North 90° 00' 00" East, a distance of 63.87 feet to said easterly line of said Southeast 1/4 of the Northeast 1/4 marked by a set 1 1/2" iron pipe; thence along said easterly line South 0° 51' 38" West, a distance of 66.01 feet to the POINT OF BEGINNING.

Subject to any easements, restrictions, or rights of way of record or of use.

The above described easement parcel to be attached to those lands described as PARCEL B hereon this survey map.


