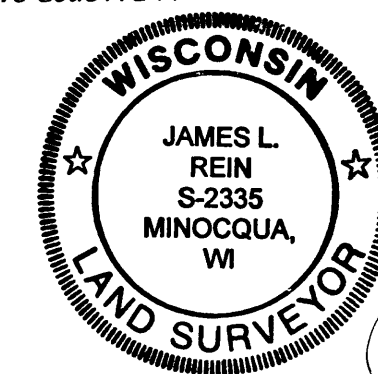

Coleman (Map No. 03-198)

That parcel of land previously described in Volume 571, on pages 724 & 725, located in Government Lot 5, Section 11, Township 39 North, Range 6 East, Minocqua Township, Oneida County, Wisconsin, being the "Coleman" parcel shown on Map No. 03-198 by Wilderness Surveying, Inc., dated February 17, 2004, more particularly described as follows:

Commencing at the south quarter corner of Section 11, marked by a capped aluminum monument; thence North 02 degrees 23 minutes 33 seconds West for a distance of 1560.86 feet along the quarter line to the center-south sixteenth corner, marked an iron pipe on the south line of Government Lot 5; thence North 89 degrees 33 minutes 18 seconds East for a distance of 192.44 feet along the south line of Government Lot 5 to an iron pipe on the westerly right of way line of U.S. Highway "51"; thence North 08 degrees 28 minutes 57 seconds East for a distance of 228.08 feet along said right of way line to the place of beginning, marked by an iron pipe.

Thence continuing along said right of way line North 08 degrees 28 minutes 57 seconds East for a distance of 94.68 feet to an iron pipe; thence North 74 degrees 26 minutes 21 seconds West for a distance of 106.09 feet to an iron pipe on the easterly right of way line of Lakeview Drive; thence along said right of way line South 16 degrees 25 minutes 42 seconds West for a distance of 80.27 feet to an iron pipe; thence South 67 degrees 52 minutes 20 seconds East for a distance of 119.76 feet to the place of beginning.

Together with and subject to covenants, easements, and restrictions of record.

Said property contains 9,670 square feet.
