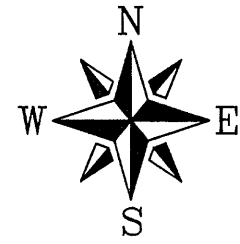
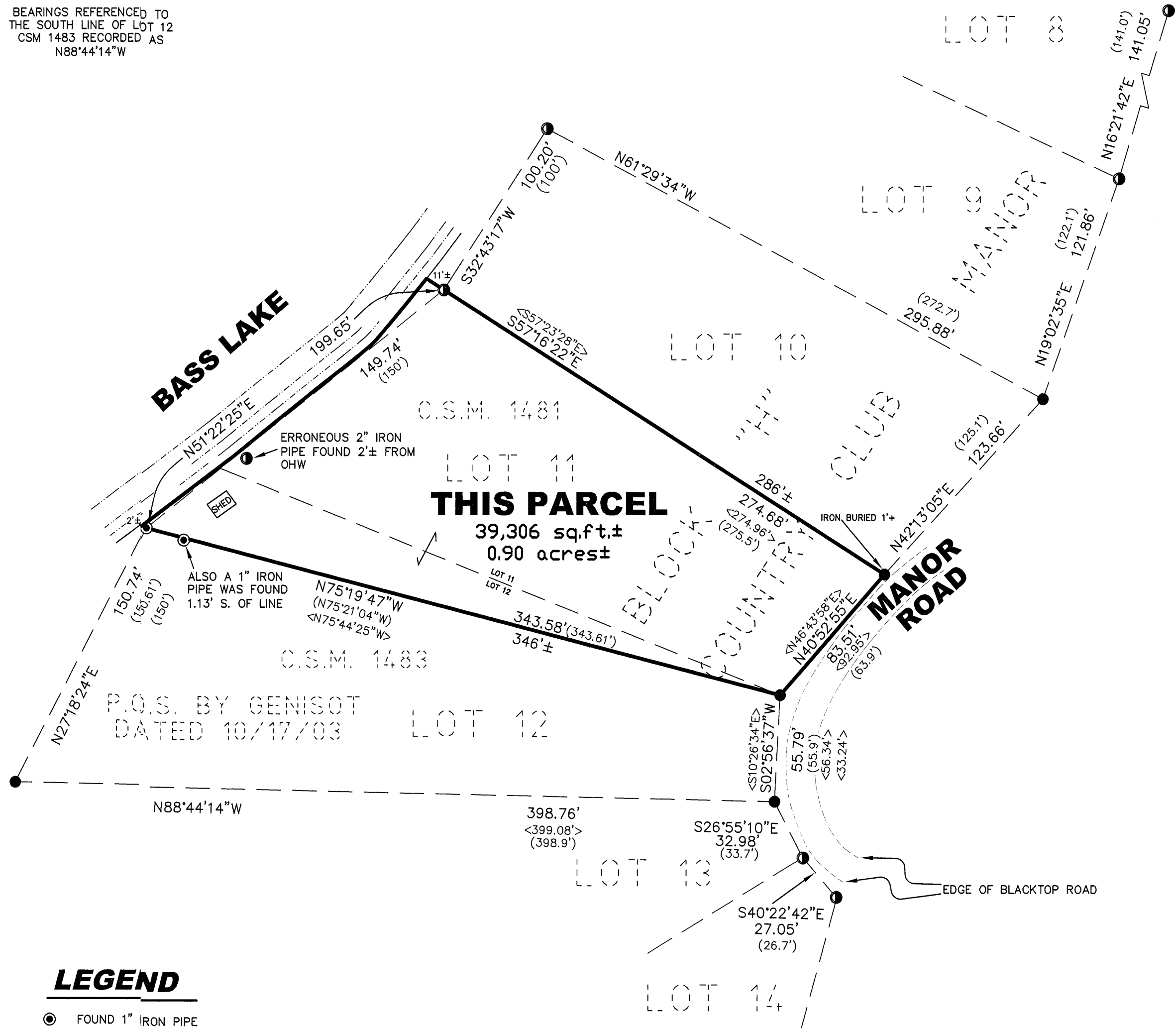

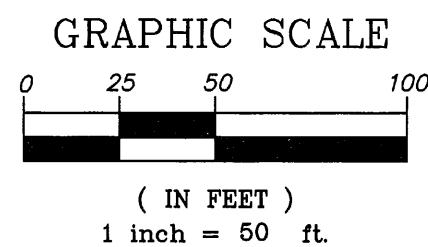


BEARINGS REFERENCED TO

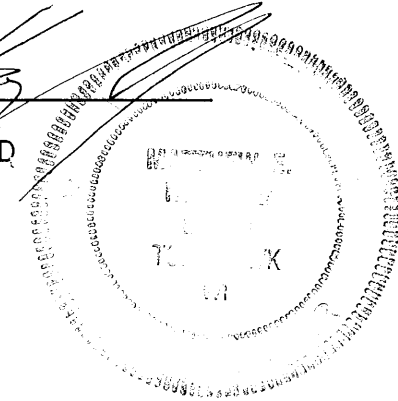
