

**Kammler Parcel (Map No. 06-06)**

That parcel of land previously described in Volume 971, on pages 737 and 738, located in Government Lot 6, Section 19, Township 39 North, Range 5 East, Minocqua Township, Oneida County, Wisconsin, being the "KAMMLER" parcel shown on Map No. 06-06 by Oestreich Surveying & Mapping, LLC, dated March 27<sup>th</sup>, 2006, more particularly described as follows:

Commencing at the east quarter corner of Section 19, marked by a capped aluminum monument; thence S00°16'09"E 1380.75 feet to the southeast corner of Government Lot 6, being the South Sixteenth Corner; thence S88°37'51"W 433.07 feet along the south line of Government Lot 6 to an iron pipe; thence N01°27'34"W 193.22 feet to an iron pipe; thence N25°30'52"E 119.47 feet to the place of beginning, being the northeast corner of that parcel of land described in Volume 720, on page 472, marked by an iron pipe.

Thence N20°08'29"E 134.27 feet to the southeast corner of that parcel of land described in Document Number 569000, marked by an iron pipe; thence along the south line of said parcel of land described in Document Number 569000 N75°25'42"W 512.34 feet to an iron pipe near the easterly shore of Squirrel Lake; thence meandering along the lake S21°15'38"W 181.24 feet to an iron pipe on the north line of that parcel of land described in Volume 720, on page 472; thence along the north line of said parcel of land described in Volume 720, on page 472 S80°31'12"E 522.48 feet to the place of beginning.

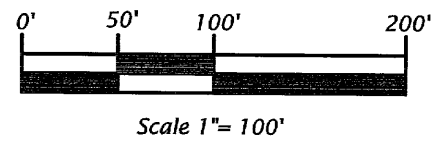

ONEIDA COUNTY, WISCONSIN

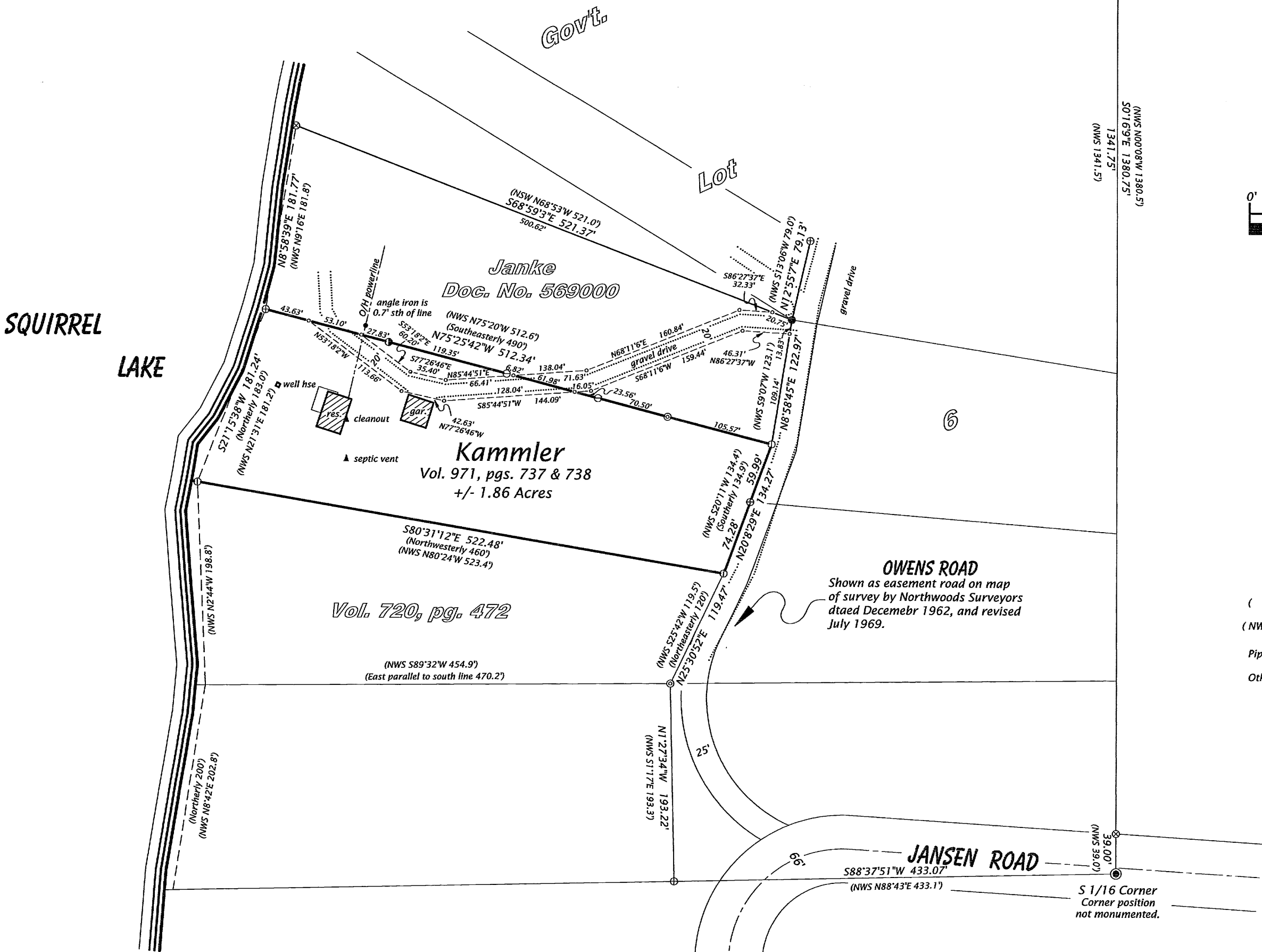

S00°16'09"E

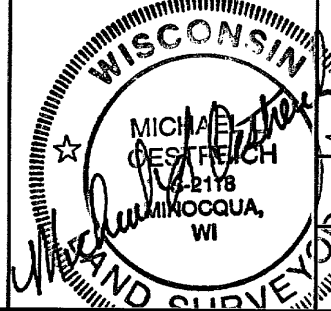
