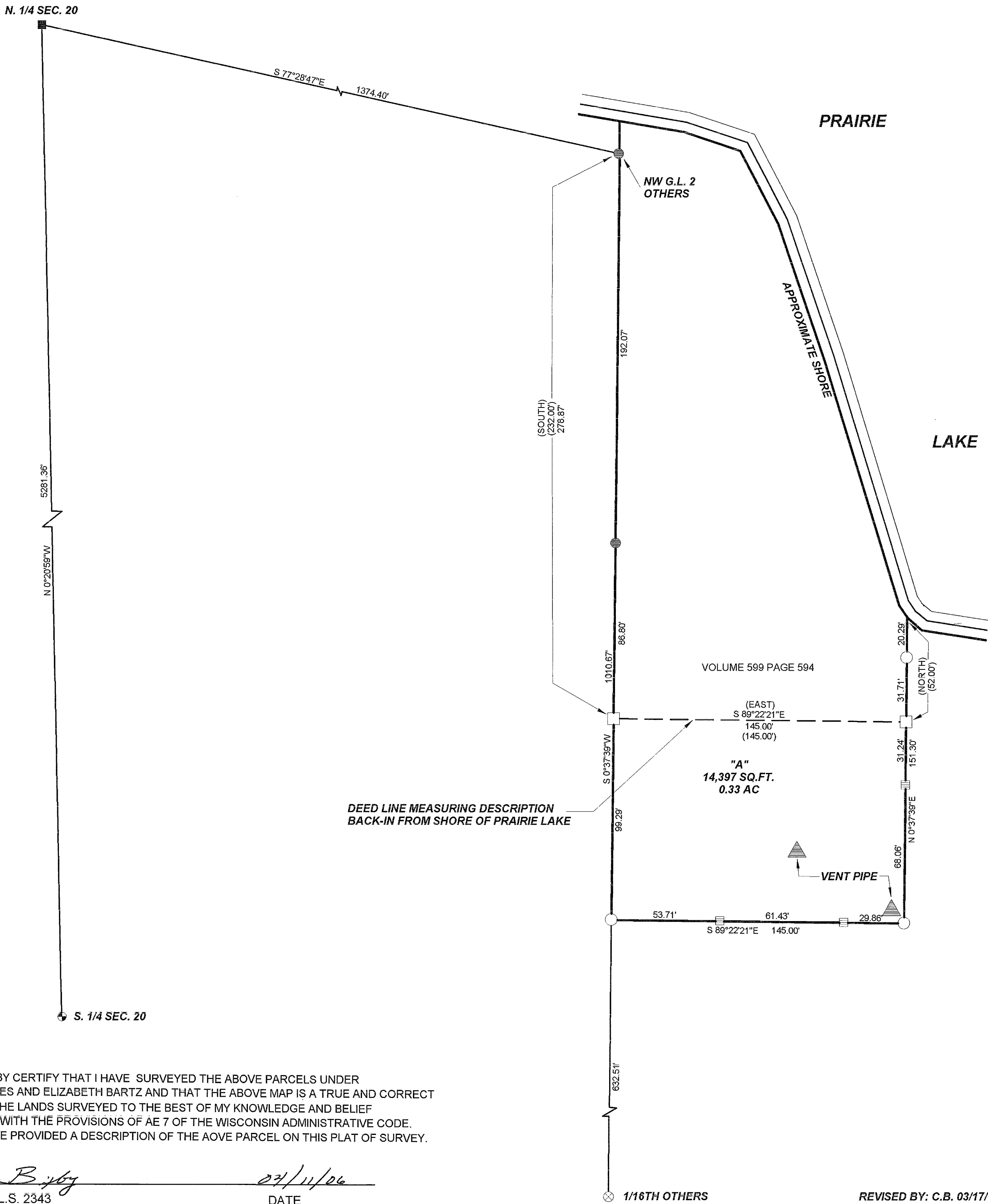

PROPERTY DESCRIPTION
PARCEL "A"

A parcel of land located in Gov't Lot 2, Section 20, T36N, R06E, Town of Nokomis, Oneida County, Wisconsin described as follows:

Commencing at the north 1/4 corner of said Section 20; thence S77°28'47"E, a distance of 1374.40' to an iron pipe on the southerly shore of Prairie Lake; thence S00°37'39"W, a distance of 278.87' to a point and point of beginning; thence S89°22'21"E, a distance of 145.00' to a point; thence S00°37'39"W, a distance of 99.30' to an iron pipe; thence N89°22'21"W, a distance of 145.00' to an iron pipe; thence N00°37'39"E, a distance of 99.29' to the point of beginning. Said parcel contains 14,397 square feet or 0.33 acres. Said parcel to be attached to the lands lying to the north and not to be sold as a separate parcel of land unless approved by the Oneida County Planning and Zoning Office. Subject to and including easements, restrictions, reservations, and right-of-ways of record or in use.
