A parcel of land previously described in Volume 625, on pages 352 & 353, being located in Government Lot 2, Section 27, Township 39 North, Range 7 East, Woodruff Township, Oneida County, Wisconsin, being parcel "A-" shown on Map No. 06-15 by Oestreich Surveying & Mapping, LLC, dated May 15th, 2006, more particularly described as follows:

Commencing at the Meander Corner where the south line of Section 27 intersects the westerly shore of Hasbrook Lake, marked by a capped aluminum monument; thence N89°06'58"W 539.37 feet along the south line of Section 27 to an iron pipe; thence N00°57'12"E 154.04 feet to the place of beginning, marked by an iron pipe on the easterly right of way line of Einer Lane.

Thence along said right of way line N00°57'12"E 65.86 feet to the southwest corner of Lot 1 in the Plat of Palmo Shores; thence along the south line of said Lot 1 N71°33'20"E 523.67 feet to an iron pipe near the westerly shore of Hasbrook Lake; thence meandering along the lake S13°52'19"E 99.88 feet to an iron pipe; thence S75°32'22"W 538.88 feet to the place of beginning.

The above lateral lot lines extend to Hasbrook Lake, and include all lands lying between the meander line and the ordinary high water mark.

Together with and subject to covenants, easements, and restrictions of record, or of use.

Said property contains 1.12 acres more or less.
