

DESCRIPTION

Part of Government Lot 9, Section 15, Township 38 North, Range 7 East, town of Lake Tomahawk, Oneida County, Wisconsin shown on a survey map by McMullen & Associates, Incorporated of Minocqua, Wisconsin dated the 26th Day of September, 2007 with a Job No. of 207069, previously described in Volume 534 on Page 42 recorded at the Oneida County Register of Deeds Office and more particularly described as follows:

Commencing at the South 1/4 Corner of said Section marked by an Aluminum Monument; thence North 45° 53' 15" East (Assumed North, Based on the Southerly line of the parcel described herein which bears South 89° 48' 00" West), a distance of 1925.27 feet to a 1 1/2" Iron Pipe on the Easterly right-of-way of Bluebird Road, said point being the POINT OF BEGINNING.

Thence leaving said right-of-way North 89° 53' 23" East, a distance of 1218.73 feet to a 1 1/2" Iron Pipe near the Westerly shore of Horsehead Lake; thence meandering along said lake shore South 4° 47' 03" East, a distance of 100.10 feet to a 1 1/2" Iron Pipe; thence leaving said lake shore South 85° 51' 48" West, a distance of 78.13 feet to a 1 1/2" Iron Pipe; thence North 80° 32' 53" West, a distance of 32.00 feet to a 1 3/4" Iron pipe; thence South 89° 48' 00" West, a distance of 1081.72 feet to a 1 1/4" Iron Pipe on said easterly right-of-way; thence North 19° 27' 07" West along said right-of-way, a distance of 107.71 feet to the POINT OF BEGINNING.

The above lateral lot lines extend to the Lake.

Said described tract containing 2.80 acres (121807 square feet), more or less.
