Commencing at the northwest corner of Section 11, marked by a capped aluminum monument; thence South 26 degrees 26 minutes 06 seconds East for a distance of 2327.85 feet to the place of beginning, marked by an iron pipe at the southeasterly corner of that parcel of land described in Volume 208, on page 67, being on the westerly right of way line of Niemi Drive.

Thence along said right of way line of Niemi Drive, South 20 degrees 00 minutes 33 seconds East for a distance of 52.40 feet to an iron pipe; thence continuing along said right of way line, North 86 degrees 15 minutes 25 seconds East for a distance of 100.82 feet to an iron pipe at that corner common with that parcel of land described in Volume 254, on page 71; thence along a line common with said parcel of land described in Volume 254, on page 71, South 55 degrees 27 minutes 08 seconds West for a distance of 370.36 feet to an iron pipe near the easterly shore of Bullhead Lake; thence meandering along said lake, North 53 degrees 55 minutes 26 seconds West for a distance of 142.76 feet to an iron pipe on the southeasterly line of that parcel of land described in Volume 208, on page 67; thence along the southeasterly line of said parcel of land described in Volume 208, on page 67, North 60 degrees 48 minutes 57 seconds East for a distance of 345.79 feet to the place of beginning.

Thence continuing along said right of way line, South 69 degrees 26 minutes 54 seconds East for a distance of 139.59 feet to iron pipe at an intersection with the northwesterly line of that parcel of land described in Volume 570, on page 3, marked by an iron pipe; thence along the northwesterly line of said parcel of land described in Volume 570, on page 3, South 58 degrees 17 minutes 17 seconds West for a distance of 416.30 feet to an iron pipe near the easterly shore of Bullhead Lake; thence meandering along the lake, North 54 degrees 41 minutes 19 seconds West for a distance of 100.00 feet to an iron pipe on the southerly line of that parcel of land described in Volume 209, on page 70; thence along the southerly line of said parcel of land described in Volume 209, on page 70, North 55 degrees 27 minutes 08 seconds East for a distance of 370.36 feet to the place of beginning.
