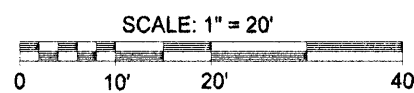

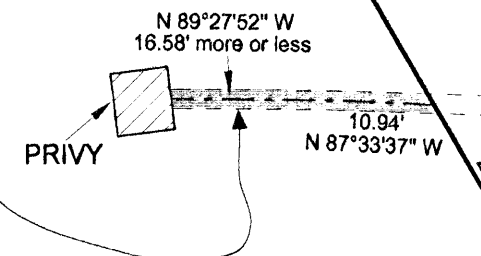
MEANDER CORNER BETWEEN
