

Tax Parcel No. 1466-16 (Map No. 07-226)

A parcel of land previously described in Volume 1010 on page 813, being part of the Northwest Quarter of the Southwest Quarter of Section 27, Township 38 North, Range 5 East, Town of Minocqua, Oneida County, Wisconsin being tax parcel No. 1466-16 shown on Map No. 07-226 by Wilderness Surveying, Inc., dated January 28, 2008 and more particularly described as follows:

Commencing at the quarter corner common to Sections 27 and 28 marked by a capped aluminum monument; thence South 00 degrees 11 minutes 40 seconds West for a distance of 329.59 feet along the west line of the Northwest Quarter of the Southwest Quarter to the place of beginning, marked by an iron pipe at the southwest corner of that parcel of land described in Document No. 608393.

Thence North 80 degrees 26 minutes 04 seconds East for a distance of 688.55 feet along the south line of said parcel of land described in Document No. 608393 to an iron pipe on the westerly right of way line of Deepwoods Lodge Road; thence South 00 degrees 58 minutes 47 seconds East for a distance of 114.76 feet along said right of way line to an iron pipe at the northeast corner of that parcel of land described in Document No. 438654; thence South 76 degrees 24 minutes 40 seconds West for a distance of 701.12 feet along the south line of said parcel of land described in Document No. 438654 to an iron pipe on the west line of the Northwest Quarter of the Southwest Quarter; thence North 00 degrees 11 minutes 40 seconds East for a distance of 165.06 feet along the west line of the Northwest Quarter of the Southwest Quarter to the place of beginning.

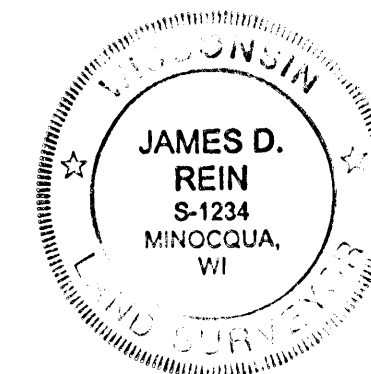
