

Part of Government Lot 4, Section 28, Township 39 North, Range 6 East, town of Minocqua, Oneida County, Wisconsin shown on a survey map by McMullen & Associates, Incorporated of Minocqua, Wisconsin dated the 18th Day of July, 2008 with a Job No. of 208051 and more particularly described as follows:

Commencing at the East 1/4 Corner of said Section marked by a Oneida County Aluminum Monument; thence North 88° 31' 11" West (Assumed North based on the Northerly line of the parcel described herein which bears South 88° 30' 10" East), a distance of 1297.42 feet to a Concrete Monument marking the Center-East 1 1/6 Corner of said Section (by others), said point being the POINT OF BEGINNING.

Thence South 0° 02' 33" East, a distance of 140.83 feet to a 1 1/2" Iron Pipe on the Westerly right-of-way of Agawak Road; thence along said right-of-way the following courses:
 South 8° 01' 59" West, a distance of 167.37 feet to a 1 1/2" Iron Pipe;
 South 3° 18' 04" West, a distance of 93.72 feet to a 1 1/2" Iron Pipe;
 South 0° 18' 28" East, a distance of 261.75 feet to a 1 1/2" Iron Pipe;

Commencing at the East 1/4 Corner of said Section marked by a Oneida County Aluminum Monument; thence North 88° 31' 11" West (Assumed North based on the Northerly line of the parcel shown on said Survey Map which bears South 88° 30' 10" East), a distance of 1297.42 feet to a Concrete Monument marking the Center-East 1 1/6 Corner of said Section (by others) thence South 0° 02' 33" East, a distance of 140.83 feet to a 1 1/2" Iron Pipe on the Westerly right-of-way of Agawak Road; thence along said right-of-way the following courses:
 South 8° 01' 59" West, a distance of 167.37 feet to a 1 1/2" Iron Pipe;
 South 3° 18' 04" West, a distance of 93.72 feet to a 1 1/2" Iron Pipe;
 South 0° 18' 28" East, a distance of 90.34 feet to a Point in the Centerline of an Existing Driveway, said point being the POINT OF BEGINNING of this centerline description.

Thence leaving said right-of-way along said Centerline the following courses:
 North 81° 34' 02" West, a distance of 67.83 feet to a Point;
 50.68 feet along the arc of a curve to the left, having a Radius of 250.00 feet, a Delta Angle of 11° 36' 51" and a Long Chord which bears North 87° 22' 28" West, 50.59 feet to a Point;

 North 2° 29' 37" East, a distance of 151.72 feet to a Mag Nail, said point being the POINT OF BEGINNING of that non-M.F.L. portion of the parcel shown on said Survey Map.

Thence continuing said meander North 1° 09' 01" East, a distance of 100.00 feet to a Mag Nail; thence leaving said lake shore South 88° 50' 59" East, a distance of 612.09 feet to a Mag Nail; thence South 12° 00' 23" West, a distance of 101.82 feet to a Mag Nail; thence North 88° 50' 59" West, a distance of 592.91 feet to the POINT OF BEGINNING.

Said non-M.F.L. portion described herein including all those lands lying between the above described meander line and the water's edge of Blue Lake.


Said non-M.F.L. portion of parcel is not a legal parcel per Oneida County Ordinances and is not to be sold separately.
