

PARCEL -2A- (Map No. 08-179)

A parcel of land, being part of Lot 2 on Oneida County Certified Survey Map No. 1513, located in the Northwest Quarter of the Northeast Quarter, Section 12, Township 39 North, Range 6 East, Town of Minocqua, Oneida County, Wisconsin, being "Parcel -2A-" shown on Map No. 08-179 by Wilderness Surveying, Inc., dated January 5, 2009, more particularly described as follows:

Commencing at the quarter corner common to Section 1 and Section 12, marked by a railroad spike in asphalt pavement; thence South 89 degrees 23 minutes 27 seconds East for a distance of 590.63 feet along to north line of Section 12; thence South 00 degrees 36 minutes 33 seconds West for a distance of 24.55 feet to an iron pipe at the northwesterly corner of Lot 1 on Oneida County Certified Survey Map No. 1513; thence South 89 degrees 19 minutes 52 seconds East for a distance of 149.88 feet along the northerly line of said Lot 1 to the place of beginning, marked by an iron pipe at the northeasterly corner of said Lot 1.

Thence continuing South 89 degrees 19 minutes 52 seconds East for a distance of 49.99 feet to an iron pipe; thence South 00 degrees 38 minutes 23 seconds West for a distance of 199.91 feet to an iron pipe on the northerly line of Lot 2 on Oneida County Survey Map No. 161; thence North 89 degrees 22 minutes 16 seconds West for a distance of 49.95 feet along the northerly line of Lot 2 on Oneida County Survey Map No. 161 to an iron pipe at the southeasterly corner of Lot 1 on Oneida County Certified Survey Map No. 1513; thence North 00 degrees 37 minutes 39 seconds East for a distance of 199.94 feet along the easterly line of said Lot 1 to the place of beginning.

Thence continuing South 89 degrees 19 minutes 52 seconds East for a distance of 49.99 feet to an iron pipe at the northwesterly corner of Lot 3 on Oneida County Certified Survey Map No. 1513; thence South 00 degrees 39 minutes 06 seconds West for a distance of 199.87 feet along the westerly line of said Lot 3 to an iron pipe at the northeasterly corner of Lot 2 on Oneida County Survey Map No. 161; thence North 89 degrees 22 minutes 16 seconds West for a distance of 49.95 feet along the northerly line of Lot 2 on Oneida County Survey Map No. 161 to an iron pipe; thence North 00 degrees 38 minutes 23 seconds East for a distance of 199.91 feet to the place of beginning.

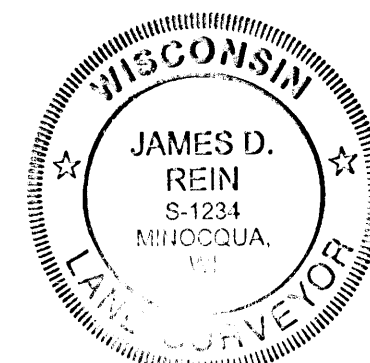

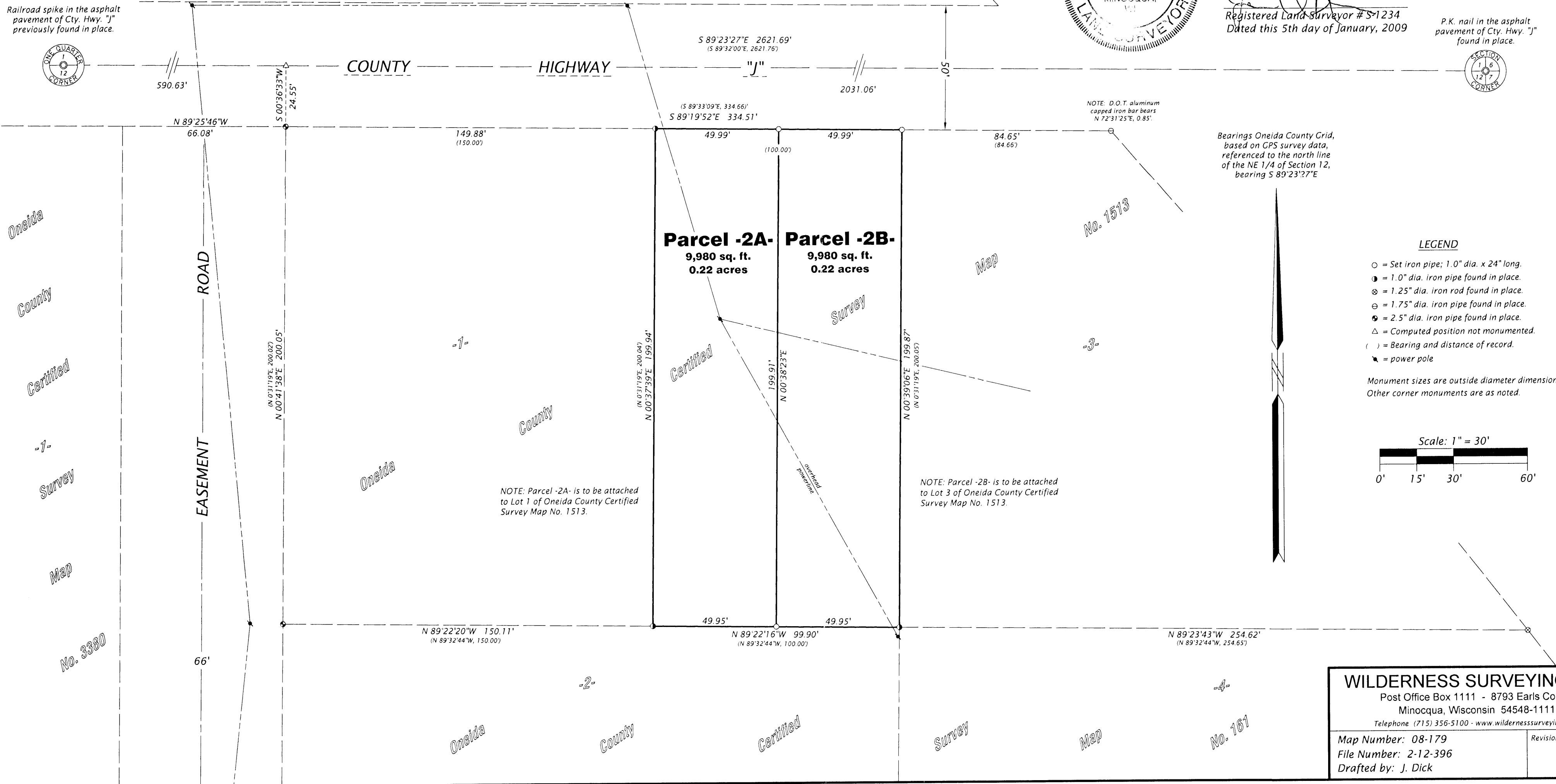
