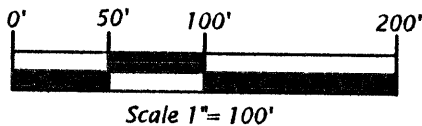


Bearing base assumed

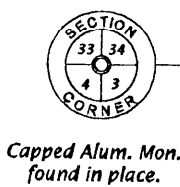
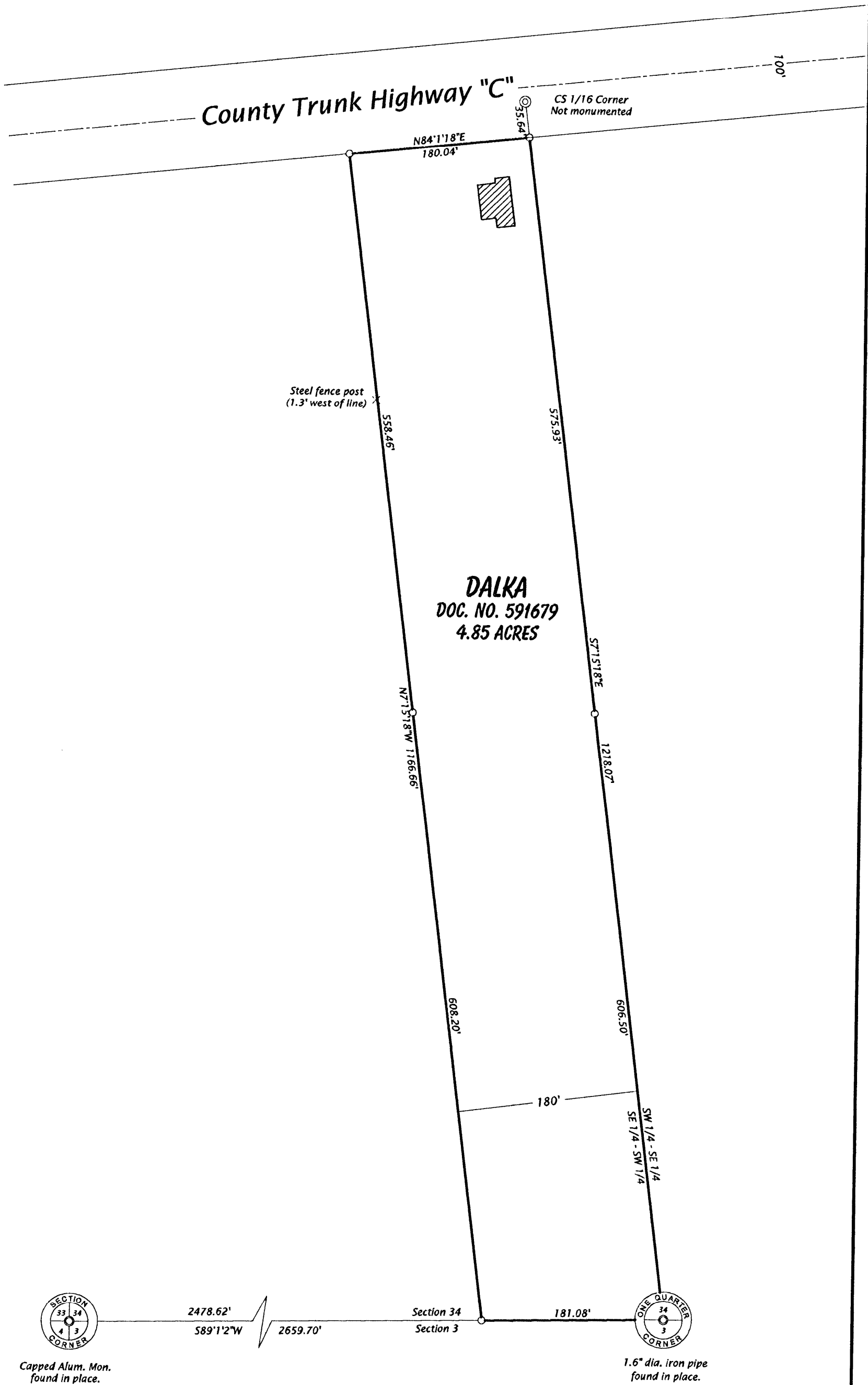
Dalka Parcel (Map No. 10-11)

That parcel of land previously described in Document Number 591679, being located in the Southeast Quarter of the Southwest Quarter, Section 34, Township 37 North, Range 9 East, Pine Lake Township, Oneida County, Wisconsin, being the "Dalka" parcel shown on Map No. 10-11 by Oestreich Surveying & Mapping, LLC, dated May 3rd, 2010, more particularly described as follows:

Beginning at the southeast corner of the Southeast Quarter of the Southwest Quarter, being the quarter corner common to Sections 3 & 34, marked by an iron pipe; thence S89°01'02"W 181.08 feet along the south line of section 34 to an iron rod; thence N07°15'18"W 1166.66 feet to the south right of way line of County Trunk Highway "C", marked by an iron rod; thence N84°01'18"E 180.04 feet along the south right of way line of County Trunk Highway "C" to an intersection with the east line of the Southeast Quarter of the Southwest Quarter, marked by an iron pipe; thence S07°15'18"E 1182.43 feet along the east line of the Southeast Quarter of the Southwest Quarter to the place of beginning.

Together with and subject to covenants, easements, and restrictions of record, or of use.

Said parcel contains 4.85 acres.
