Beginning at the northernmost corner of Lot 3, Block "C", in the recorded Plat of GOLF CLUB SUBDIVISION, marked by an iron pipe; thence along the northerly line of said Lot 3, South 62 degrees 41 minutes 14 seconds East for a distance of 157.26 feet to an iron pipe on the northwesterly right of way line of Bozile Road; thence along said right of way line, South 51 degrees 30 minutes 24 seconds West for a distance of 62.80 feet to a Berntsen survey marker nail set in the paved driveway at the corner common to Lots 2 and 3; thence continuing along said right of way line, South 55 degrees 37 minutes 17 seconds West for a distance of 33.69 feet to an iron pipe at the northeasterly corner of that parcel of land previously described in Document Number 531350; thence along the northerly line of said parcel of land previously described in Document Number 531530, North 61 degrees 27 minutes 34 seconds West for a distance of 115.20 feet to an iron pipe on the westerly line of Block "C"; thence along the westerly line of Block "C", North 27 degrees 04 minutes 00 seconds East for a distance of 30.01 feet to the corner common to Lots 2 and 3, marked by an iron pipe; thence continuing along the westerly line of Block "C", North 27 degrees 04 minutes 00 seconds East for a distance of 54.47 feet to the place of beginning.

Beginning at the southernmost corner of Lot 1, Block "C", in the recorded Plat of GOLF CLUB SUBDIVISION, marked by an iron axle shaft; thence along the westerly line of said Block "C", North 27 degrees 04 minutes 00 seconds East for a distance of 181.60 feet to the corner common to Lots 1 and 2, marked by an iron pipe; thence continuing along the westerly line of said Block "C", North 27 degrees 04 minutes 00 seconds East for a distance of 25.66 feet to southwesterly corner of that parcel of land previously described in Document Number 531351; thence along the southerly line of said parcel of land previously described in Document Number 531351, South 61 degrees 27 minutes 34 seconds East for a distance of 115.20 feet to an iron pipe on the northwesterly right of way line of Bozile Road; thence along said right of way line, South 55 degrees 37 minutes 17 seconds West for a distance of 29.31 feet to the corner common to Lots 1 and 2, marked by an iron rod; thence continuing along said right of way line, South 56 degrees 35 minutes 59 seconds West for a distance of 205.22 feet to the place of beginning.
