Part of Government Lot 8, Section 26, Township 39 North, Range 7 East, Town of Woodruff, Oneida County, Wisconsin shown on a survey map by McMullen & Associates, Incorporated of Minocqua, Wisconsin dated the 30th Day of September, 2010 with a Job No. of 210056 and more particularly described as follows:

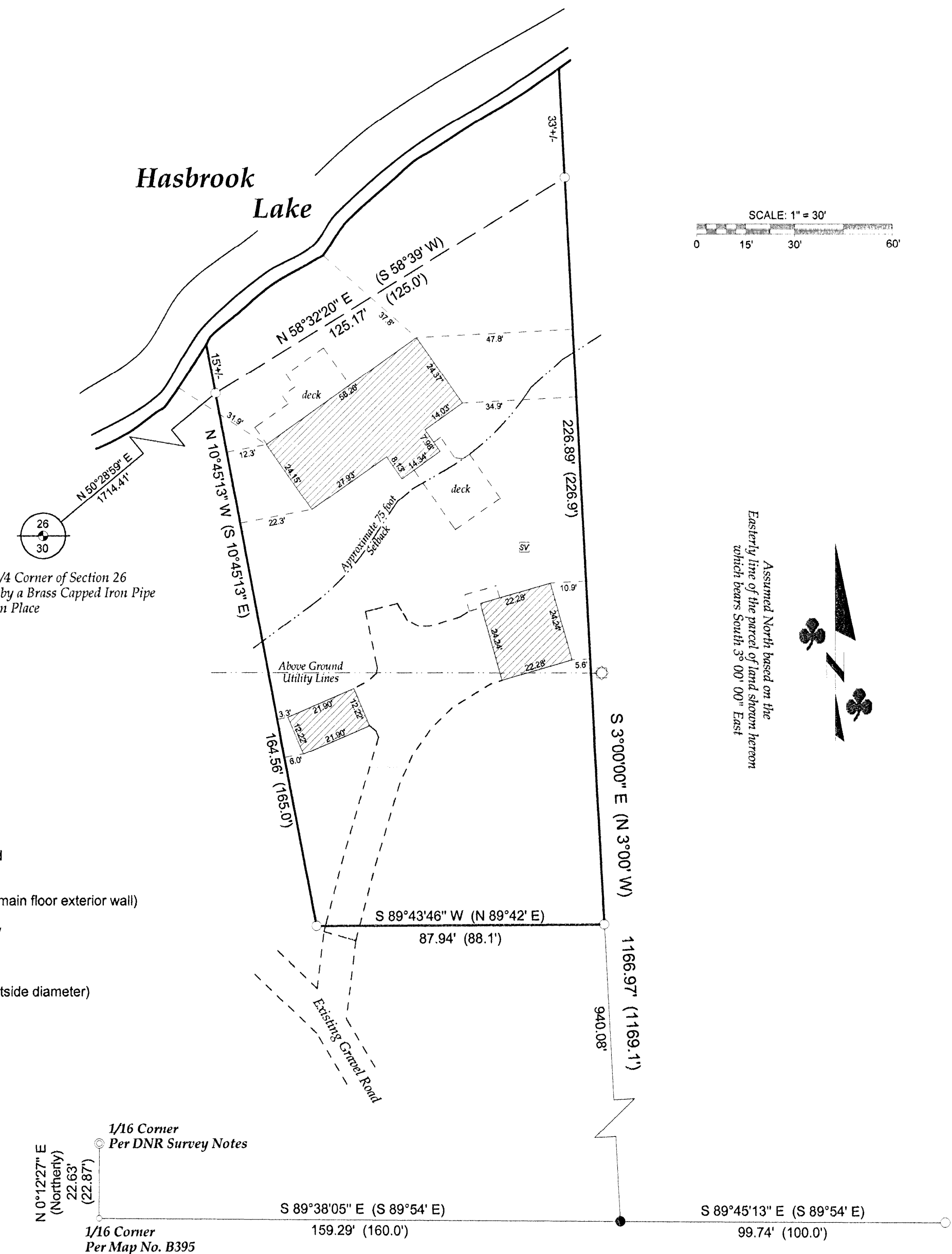
Commencing at the South 1/4 Corner of said Section marked by a Brass Capped Iron Pipe; thence North 50° 28' 59" East (Assumed North based on the Easterly line of the parcel of land described herein which bears South 3° 00' 00" East), a distance of 1714.41 feet to a found 1.660" Iron Pipe near the Southerly shore of Hasbrook Lake, said point being the POINT OF BEGINNING.

Thence meandering along said shore North 58° 32' 20" East, a distance of 125.17 feet to a found 1.660" Iron Pipe; thence leaving said lake shore South 3° 00' 00" East, a distance of 226.89 feet to a found 1.660" Iron Pipe; thence South 89° 43' 46" West, a distance of 87.94 feet to a found 1.660" Iron Pipe; thence North 10° 45' 13" West, a distance of 164.56 feet to the POINT OF BEGINNING.

Including all those lands lying between the above described meander line and the water's edge of Hasbrook Lake.

Together with easements / rights per Document No. 593553 recorded at the Oneida County Register of Deeds Office.

Subject to any easements, restrictions, or rights of way of record or of use.
