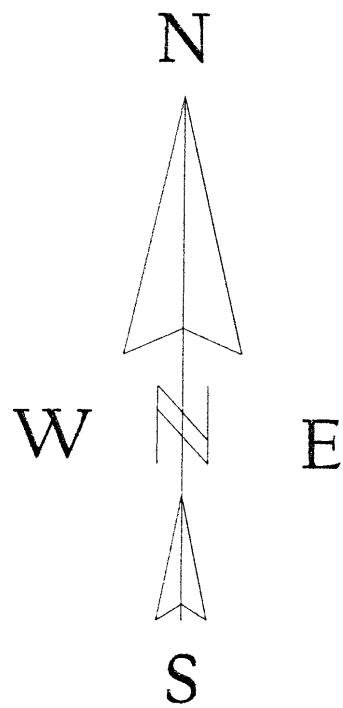

BEAR S00°25'00"W.



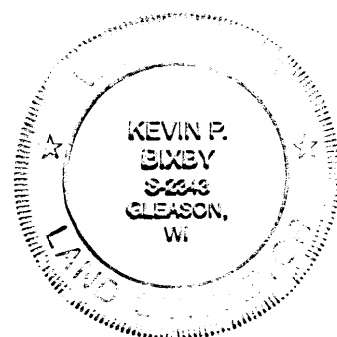
EAST LINE LOT # 64, PELICAN
