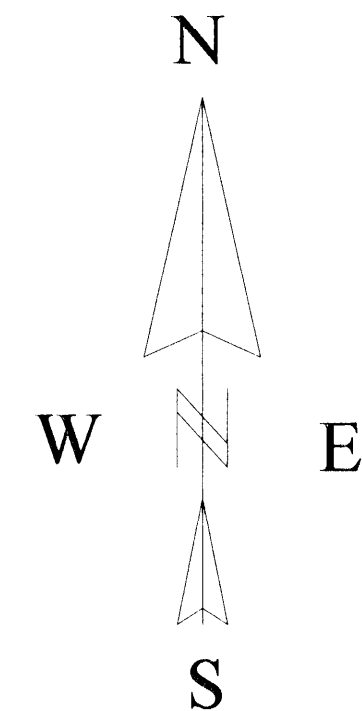
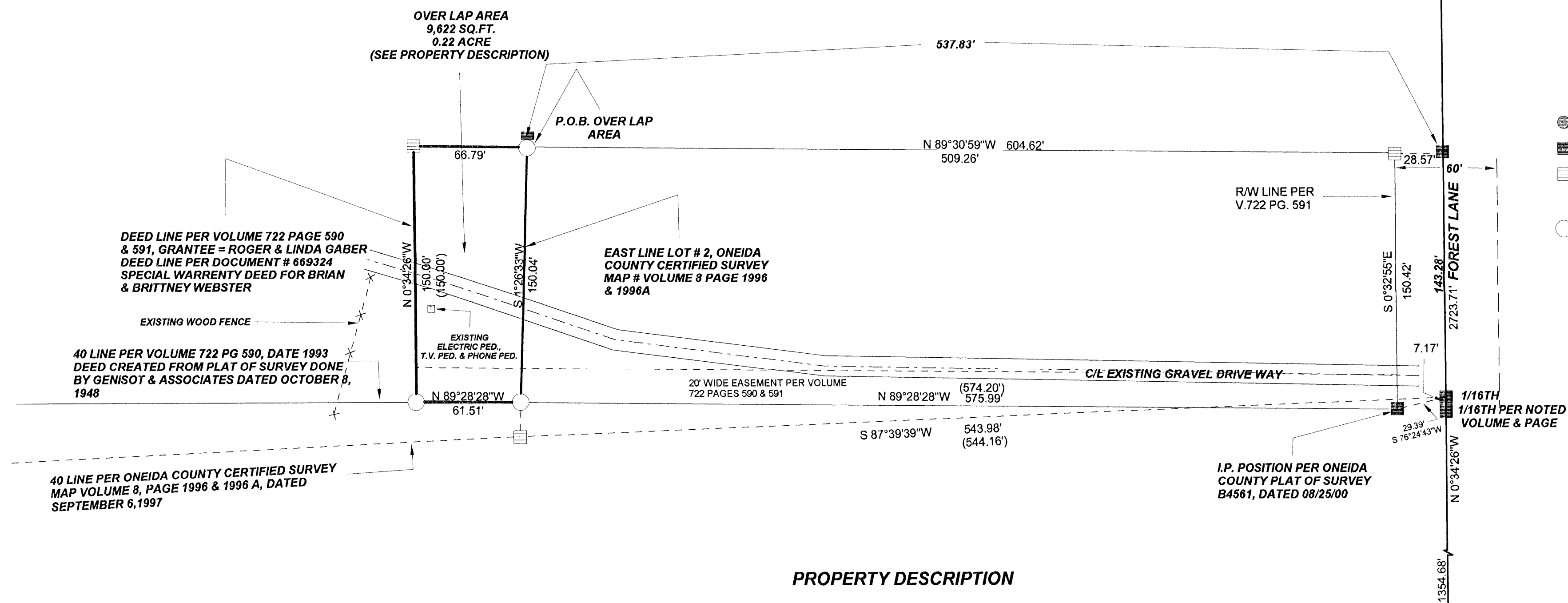

**PROPERTY DESCRIPTION**

A parcel of land located in The NE 1/4 - SE 1/4, Section 22, T37N, R08E, as recorded in Volume 722, Pages 590 and 591 of Oneida County Register of Deeds and part of Lot 2, Oneida County Certified Survey Map, Volume 8, Page 1996 and 1996A, Town of Newbold, Oneida County, Wisconsin, described as follows:

Commencing at the east 1/4 corner of said section 22; thence S00°34'26"E, a distance of 1218.58 feet to a point; thence N89°30'59"W, a distance of 537.83 feet to a railroad spike and point of beginning; thence S01°26'33"W, a distance of 150.04 feet to a railroad spike; thence N89°28'28"W, a distance of 61.51 feet to a railroad spike; thence N00°34'26"W, a distance of 150.00 feet to an iron pipe; thence S89°30'59"E, a distance of 66.79 feet to the point of beginning. Said parcel contains 9,622 sq.ft. or 0.22 acre. Subject to and including easements, restrictions, reservations and right-of-ways of record or in use.
