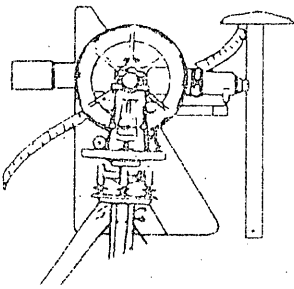

### DESCRIPTION TO ACCOMPANY MAP # 11248

A parcel of land located in part of Lots 12 and 13, Crescent Lake Subdivision and part of Gov't Lot 5, Section 17, T 36 N, R 8 E, Town of Crescent, Oneida County, Wisconsin described as follows:

Commencing at the most southerly corner of said Lot 13 marked by an iron pipe on the northwesterly shore of Crescent Lake and point of beginning, thence leaving said shoreline and along a line by agreement N 38°33'03" W a distance of 139.00' to an iron pipe, thence continuing along said agreement line N 16°05'54" W a distance of 2.42' to an iron pipe, thence N 39°08'41" W a distance of 147.00' to an iron pipe on the on southerly right of way line of Wausau Road and end of said agreement line, thence along said right of way line N 80°11'37" E a distance of 102.06' to an iron pipe, thence leaving said right of way line S 41°12'09" E a distance of 239.74' to an iron pipe on the northwesterly shore of Crescent Lake, thence along the meander line of said lake S 51°38'23" W a distance of 99.98' to the point of beginning.

Parcel contains 24,739 sq. ft.

Subject to easements, restrictions, reservations and right of way of record or in use.

Including those lands lying between the above described meander line and normal high water mark of Crescent Lake.
