PARCEL -A- (MAP NO. 13-47)
That parcel of land previously described in Document Number 705123, being part of Lot 27 in the Plat of Blue Lake Island, located in Government Lot 7, Section 28 and in Government Lot 6, Section 29, Township 39 North, Range 6 East, Town of Minoqcu, Oneida County, Wisconsin, being parcel "A" shown on Map No. 13-47 by Wilderness Surveying, Inc., dated February 20, 2014, more particularly described as follows:

Beginning at the southeasterly corner of said Lot 27, marked by an iron pipe on the westerly right of way line of Blue Lake Island Road; thence N59°15'46"W for a distance of 280.12 feet to an iron pipe near the easterly shore of Blue Lake; thence meandering along the lake N20°47'19"E for a distance of 96.73 feet to an iron pipe; thence S46°54'58"E for a distance of 78.42 feet to an iron pipe; thence S64°35'24"E for a distance of 218.48 feet to an iron pipe on the westerly right of way line of Blue Lake Island Road; thence S29°10'43"W for a distance of 98.83 feet along the westerly right of way line of Blue Lake Island Road to the place of beginning.

The above lateral lot lines extend to Blue Lake and include all that land lying between the meander line and the ordinary high water mark.

Said parcel of land contains 0.60 acres more or less.
