

**CENTERLINE DESCRIPTION OF SILVER LAKE ROAD**

Part of Government Lots 1 & 2, Section 5, Township 38 North, Range 6 East, Town of Hazelhurst, Oneida County, Wisconsin as shown on a survey map by McMullen & Associates, Incorporated of Minocqua, Wisconsin dated the 22<sup>nd</sup> day of February, 2016 with a job number of 215033 and more particularly described as follows:

Commencing at the Meander Corner on the south side of Silver Lake; thence crossing said lake North 2° 31' 13" East (magnetic north base on said line), a distance of 2020.14 feet to the North 1/16 Corner marked by an aluminum cap in the roadbed of Lower Kaubashine Road; thence South 4° 36' 59" West, a distance of 15.00 feet to a point on the southerly right-of-way of said road; thence along said right-of-way South 85° 35' 33" East, a distance of 140.00 feet to a 2.375" iron pipe; thence continuing along said right-of-way South 85° 06' 47" East, a distance of 392.60 feet to a point which is at the intersection of said right-of-way and the westerly right-of-way of Silver Lake Road herein described and as shown on a survey map by William Cameron with a revised date of February, 1973; thence continuing along said southerly right-of-way to the intersection of the centerline of said Silver Lake Road North 83° 35' 06" East, a distance of 33.86 feet to a point, said point being the POINT OF BEGINNING of this centerline description for a 66' wide road (Silver Lake Road).

Thence along the centerline of this 66' wide road the following courses:

Along the centerline as shown on said survey map by William Cameron the following courses:

South 19° 16' 37" East, a distance of 111.91 feet to a point;

South 26° 49' 29" East, a distance of 93.24 feet to a point;

South 41° 13' 00" East, a distance of 297.31 feet to a point;

South 5° 51' 38" West, a distance of 268.16 feet to a point which is the Point of Beginning of document number 249758 recorded at the Oneida County Register of Deeds office;

thence leaving said centerline as shown on said survey map by William Cameron and continuing along the centerline of this 66' wide road the following courses:

South 11° 34' 31" East, a distance of 312.26 feet to a point;

South 0° 14' 43" East, a distance of 136.25 feet to a point;

South 27° 06' 52" West, a distance of 259.75 feet to a point;

South 16° 27' 07" West, a distance of 227.42 feet to a point;

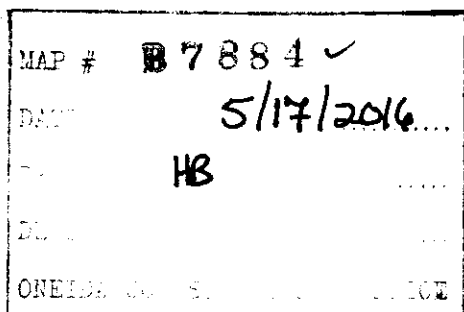
South 30° 33' 14" West, a distance of 169.81 feet to a point;

South 38° 00' 36" West, a distance of 100.90 feet to a point;

South 58° 52' 09" West, a distance of 384.86 feet to a point which is on the northeasterly line of the parcel with a tax identification number of HA 41 - 11, the POINT OF ENDING of this centerline description.

The right-of-way lines of this 66' wide road (Silver Lake Road) are intended to be extended to and terminate at the southerly right-of-way line of Lower Kaubashine Road and to be extended to and terminate at the northeasterly line of the parcel with a tax identification number of HA 41 - 11.

Subject to any easements, restrictions, or rights of way of record or of use.
