Commencing at the corner common to Sections 3, 4 9 and 10, marked by a concrete monument; thence S 57°30'19"E for a distance of 1765.54 feet to an iron pipe near the southerly shore of Alice Lake on the westerly line of that parcel of land described in Volume 767 Records, page 578; thence S 09°56'06"E for a distance of 180.85 feet along the westerly line of that parcel of land described in Volume 767 Records, page 578, to the place of beginning of said easement.

Thence S 75°22'07"W for a distance of 5.76 feet; thence S 14°37'53"E for a distance of 50.25 feet; thence N 75°22'07"E for a distance of 1.63 feet to the westerly line of that parcel of land described in Volume 767 records, page 578 and there terminating.

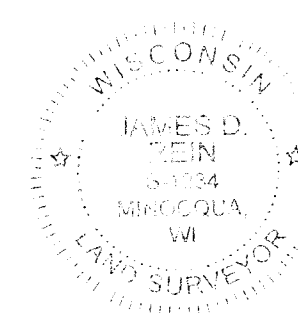

A parcel of land in the Northeast Quarter of the Northwest Quarter, Section 10, Township 38 North, Range 6 East, Town of Hazelhurst, Oneida County, Wisconsin, being parcel "A-", shown on Map No. 18-220, by Wilderness Surveying, Inc., dated December 5, 2018, more particularly described as follows:

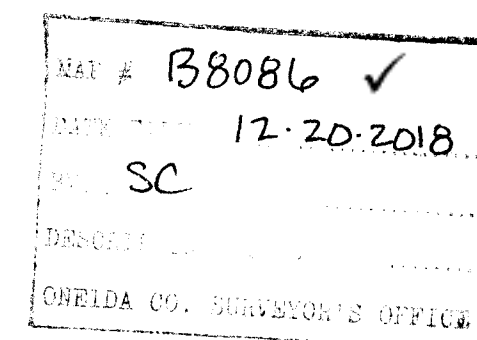
Commencing at the corner common to Sections 3, 4, 9 and 10, marked by a concrete monument; thence S 57°30'19"E for a distance of 1765.54 feet to the place of beginning, marked by an iron pipe near the southerly shore of Alice Lake on the easterly line of that parcel of land described in Document Number 753680.

Thence meandering along the lake, N 71°01'44"E for a distance of 161.34 feet to an iron pipe on the westerly line of Lot 1 of Certified Survey Map Number 1719; thence S 15°10'13"E for a distance of 255.79 feet along the westerly line of Lot 1 of said Certified Survey Map Number 1719 to an iron pipe on the northerly right of way line of Cedar Falls Road; thence S 65°15'58"W for a distance of 188.94 feet along the northerly right of way line of Cedar Falls Road to an iron pipe at the southeasterly corner of that parcel of land described in Document Number 753680; thence N 09°56'06"W for a distance of 277.65 feet along the easterly line of that parcel of land described in Document Number 753680 to the place of beginning.

The above described lateral lot lines extend to the southerly shore of Alice Lake; and includes all those lands lying between the meander line and the ordinary high water mark.
