PARCEL -5- (Map No. 19-81)

A parcel of land in the Northeast Quarter of the Northwest Quarter, Section 27, Township 39 North, Range 6 East, Town of Minocqua, Oneida County, Wisconsin, being parcel "-5-", shown on Map No. 19-81, by Wilderness Surveying, Inc., dated July 12, 2019, more particularly described as follows: Commencing at the quarter corner common to Sections 22 and 27, marked by a capped aluminum monument; thence S 31°37'10"W for a distance of 651.41 feet to the place of beginning, marked by an iron pipe on the westerly line of that parcel of land described in Document Number 786759 near the southerly shore of Bolger Lake.

Thence S 32°28'27"W for a distance of 401.18 feet along the westerly line of that parcel of land described in Document Number 786759 to an iron pipe on the northeasterly line of that parcel of land described in Volume 393 Records, page 331; thence N 57°23'58"W for a distance of 118.03 feet along the northeasterly line of that parcel of land described in Volume 393 Records, page 331 to an iron pipe at the southeasterly corner of that parcel of land described in Document Number 768095; thence N 32°27'40"E for a distance of 329.05 feet along the easterly line of that parcel of land described in Document Number 768095 to an iron pipe near the southerly shore of Bolger Lake; thence meandering along the lake, S 88°50'48"E for a distance of 138.25 feet to the place of beginning.

The above described lateral lot lines extend to the southerly shore of Bolger Lake; and includes all those lands lying between the meander line and the ordinary high water mark.

Commencing at the quarter corner common to Sections 22 and 27, marked by a capped aluminum monument; thence S 31°37'10"W for a distance of 651.41 feet to an iron pipe on the easterly line of that parcel of land described in Document Number 781002 near the southerly shore of Bolger Lake; thence meandering along the lake, N 88°50'48"W for a distance of 138.25 feet to the place of beginning, marked by an iron pipe on the westerly line of that parcel of land described in Document Number 781002.

Thence S 32°27'40"W for a distance of 329.05 feet along the westerly line of that parcel of land described in Document Number 781002 to an iron pipe on the northeasterly line of that parcel of land described in Volume 393 Records, page 331; thence along the northerly and easterly lines of said parcel of land described in Volume 393 Records, page 331, N 57°23'58"W for a distance of 198.94 feet to an iron pipe; and N 32°36'36"E for a distance of 412.03 feet to an iron pipe near the southerly shore of Bolger Lake; thence meandering along the lake, N 68°38'46"E for a distance of 123.50 feet; S 16°59'27"W for a distance of 159.38 feet; S 15°32'50"E for a distance of 71.07 feet; and S 88°50'48"E for a distance of 34.67 feet to the place of beginning.

The above described lateral lot lines extend to the southerly shore of Bolger Lake; and includes all those lands lying between the meander line and the ordinary high water mark.
