


**PARCEL MI-1685-1 (Map No. 22-102)**

A parcel of land in Government Lots 2 and 3, Section 8, Township 39 North, Range 5 East, Town of Minocqua, Oneida County, Wisconsin, being parcel "MI-1685-1", shown on Map No. 22-102, by Wilderness Surveying, Inc., dated September 22, 2022, more particularly described as follows:

Commencing at the corner common to Sections 4, 5, 8 and 9, marked by a brass capped iron pipe; thence S 29°42'00"W for a distance of 2828.54 feet to the place of beginning, marked by an iron pipe on the southerly right of way line of Kobart Road and the northwest corner of Tax Parcel Number MI-1685-5.

Thence along the westerly line of Tax Parcel Number MI-1685-5, S 02°05'51"W for a distance of 583.62 feet to an iron pipe; and S 56°56'14"W for a distance of 100.12 feet to an iron pipe near the northerly shore of Squirrel Lake; thence meandering along the lake, N 57°04'29"W for a distance of 128.57 feet to an iron pipe on the easterly line of Tax Parcel Number MI-1685-4; thence N 05°49'42"E for a distance of 552.18 feet along the easterly line of Tax Parcel Number MI-1685-4, to an iron pipe on the southerly right of way line of Kobart Road; thence N 83°14'05"E for a distance of 158.22 feet along the southerly right of way line of Kobart Road to the place of beginning.

The above described lateral lot lines extend to the northerly shore of Squirrel Lake; and includes all those lands lying between the meander line and the ordinary high water mark.

Together with and subject to covenants, easements, and restrictions of record.

Said property contains 2.42 acres, more or less.

Commencing at the corner common to Sections 4, 5, 8 and 9, marked by a brass capped iron pipe; thence S 29°42'00"W for a distance of 2828.54 feet to the northwest corner of Tax Parcel Number MI-1685-5, on the southerly right of way line of Kobart Road, marked by an iron pipe; thence S 83°14'05"W for a distance of 158.22 feet along the southerly right of way line of Kobart Road, to the place of beginning, marked by an iron pipe at the northwest corner of Tax Parcel Number MI-1685-1.

Thence along the westerly line of Tax Parcel Number MI-1685-1, S 05°49'42"W for a distance of 552.18 feet along the westerly line of Tax Parcel Number MI-1685-1 to an iron pipe near the northerly shore of Squirrel Lake; thence meandering along the lake, N 76°58'27"W for a distance of 118.55 feet to an iron pipe on the easterly line of Tax Parcel Number MI-1685-11; thence N 06°11'53"E for a distance of 496.62 feet along the easterly line of Tax Parcel Number MI-1685-11, to an iron pipe on the southerly right of way line of Kobart Road; thence N 76°14'18"E for a distance of 121.44 feet along the southerly right of way line of Kobart Road to the place of beginning.

The above described lateral lot lines extend to the northerly shore of Squirrel Lake; and includes all those lands lying between the meander line and the ordinary high water mark.

Together with and subject to covenants, easements, and restrictions of record.

Said property contains 1.41 acres, more or less.
