SURVEYOR'S CERTIFICATE

I, JAMES G. GRIFFIN, registered land surveyor, hereby certify:
That I have surveyed, divided and mapped ROCKWOOD ESTATES SOUTH DIVISION 3, located in the Town of MINOCQUA, County of ONEIDA and State of Wisconsin.
That I have made such survey, land-division and plat by the direction of RABER-KIEF, a Co-partnership, owners of said land. Being a parcel of land in Gov't. Lot 1, Section 1, T 39 N, R 5 E, Oneida County, Wisconsin, more particularly described as follows:
Commencing at the north one-quarter corner of Section 1; thence N. 89° - 57' W., 191.20 feet along the north line of Section 1 to the place of beginning, marked by an iron pipe.
