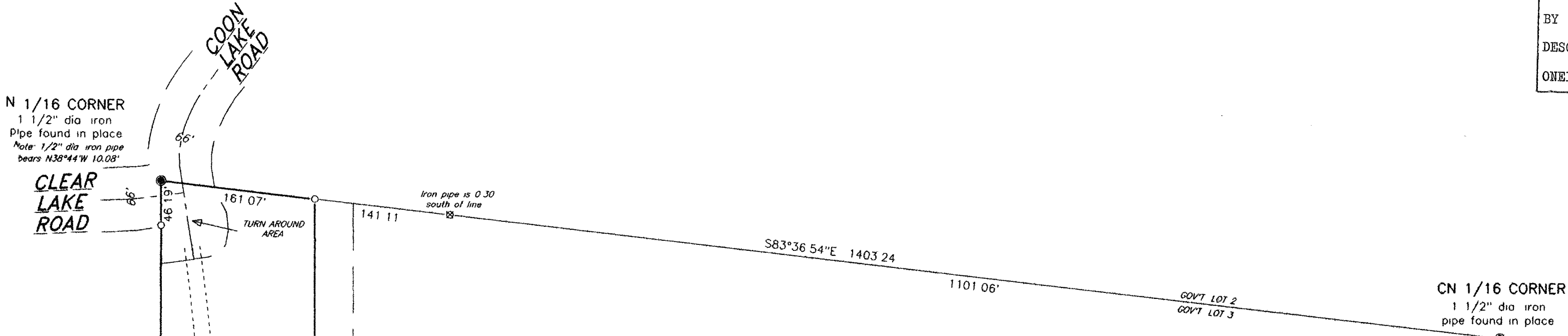

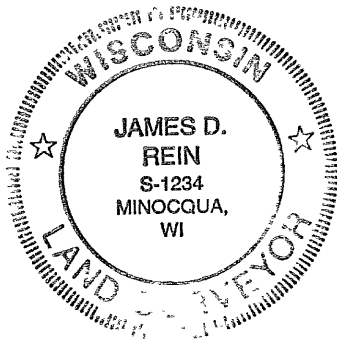

**SECTION 19, T37N, R8E**

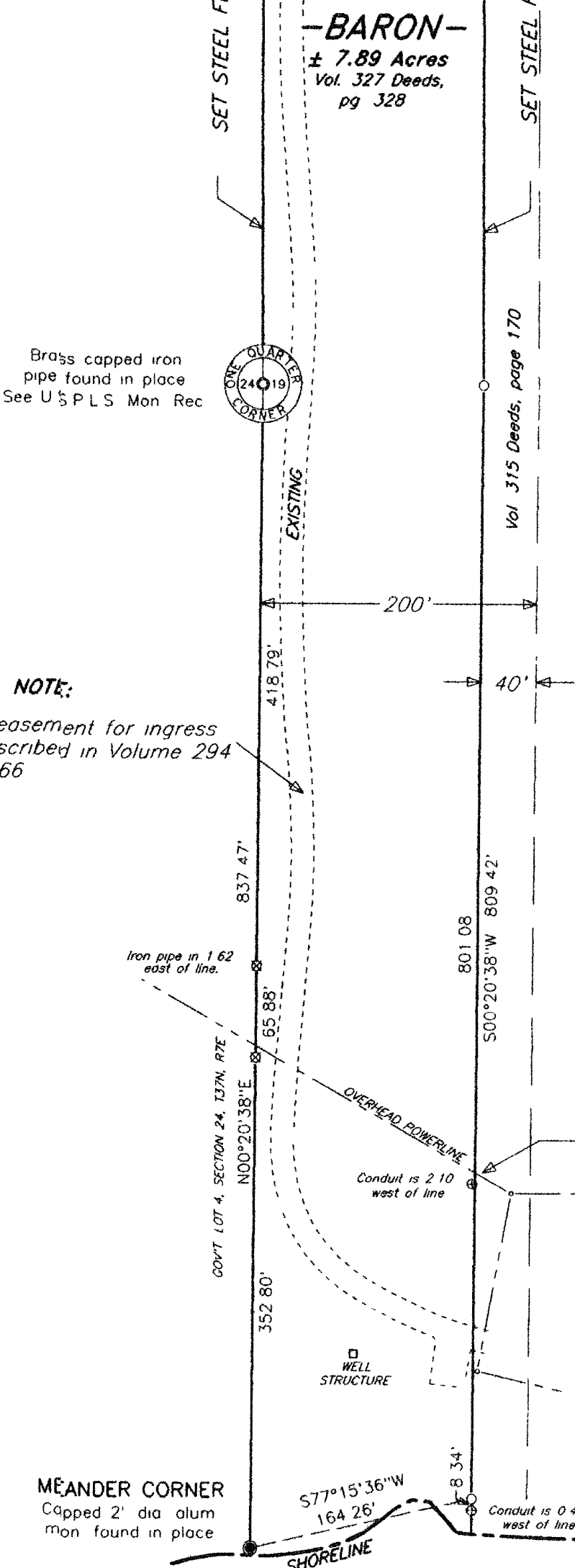

**BARON PARCEL**

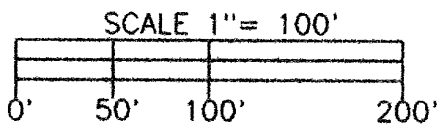
The west 160 feet of Government Lot 3, Section 19, Township 37 North, Range 8 East, Newbold Township, Oneida County, Wisconsin, being the "BARON" parcel shown on Map No 96-98 by Wilderness Surveying, Inc., dated October 17th, 1996, more particularly described as follows:

Beginning at the Meander Corner, where the west line of Section 19 intersects the northerly shore of Mildred Lake, marked by a capped aluminum monument; thence North 00 degrees 20 minutes 38 seconds East for a distance of 837.47 feet along the west line of Section 19 to the quarter corner common to Section 19 and Section 24, marked by a brass capped iron pipe; thence continuing along the west line of Section 19 North 00 degrees 13 minutes 32 seconds West for a distance of 1332.32 feet to the northwest corner of Government Lot 3, being the North Sixteenth Corner, marked by an iron pipe; thence South 83 degrees 36 minutes 54 seconds East for a distance of 161.07 feet along the north line of Government Lot 3 to an aluminum capped iron pipe; thence South 00 degrees 13 minutes 32 seconds East for a distance of 1314.57 feet to an iron pipe; thence South 00 degrees 20 minutes 38 seconds West for a distance of 801.08 feet to an aluminum capped iron pipe near the northerly shore of Mildred Lake, thence meandering along the lake South 77 degrees 15 minutes 36 seconds West for a distance of 164.26 feet to the place of beginning

The above lateral lot lines extend to the shore of Mildred Lake, and include all lands lying between the meander line and the ordinary high water mark.

Together with and subject to covenants, easements, and restrictions of record.

Said property contains 7.89 acres more or less
