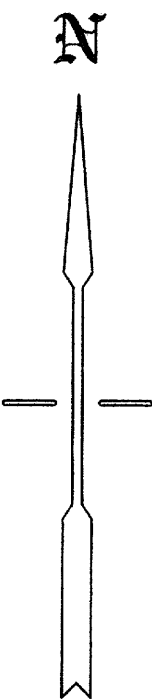
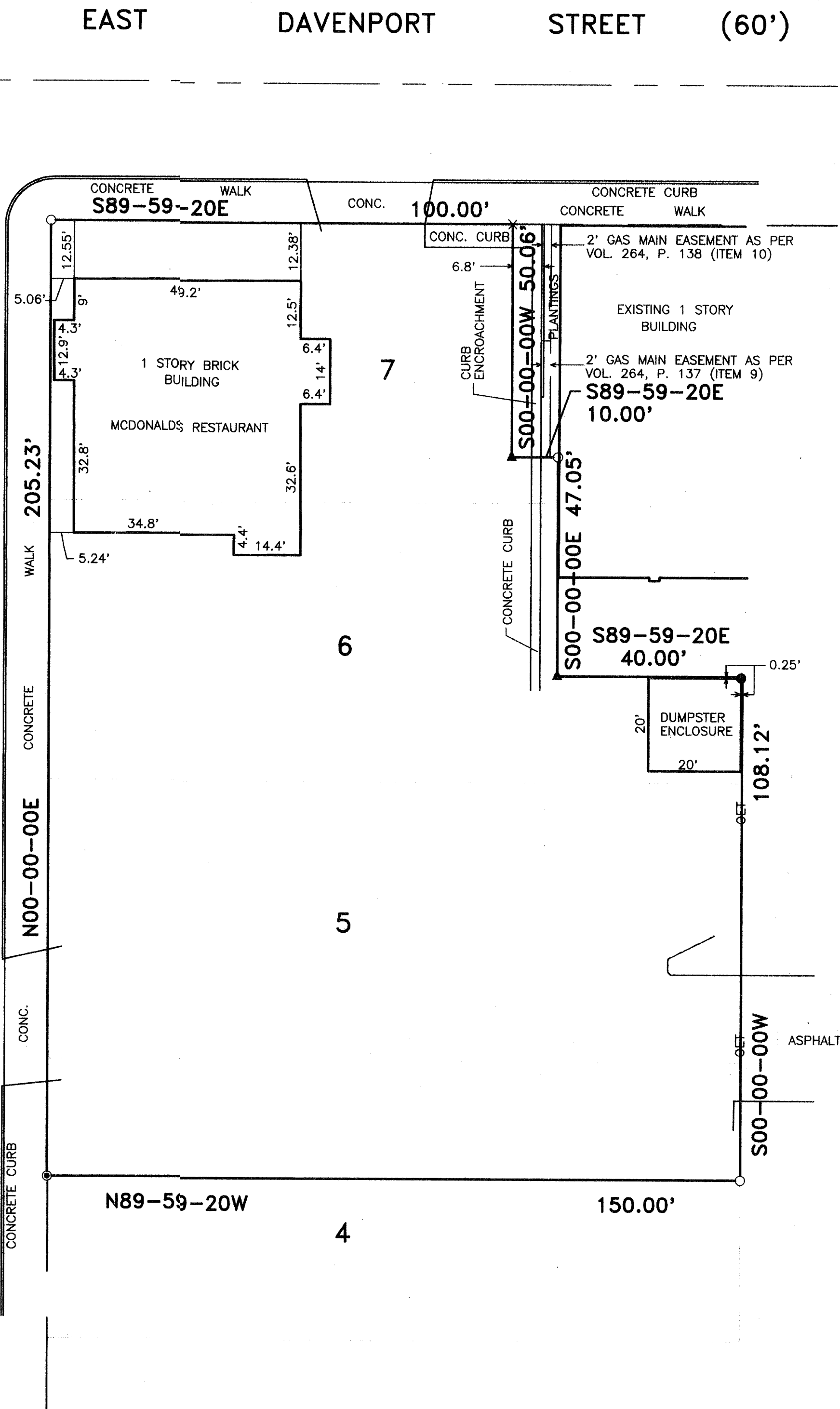

DESCRIPTION:  
A PARCEL OF LAND BEING A PART OF LOTS 4, 5, 6 AND 7 OF BLOCK 26, ORIGINAL PLAT, CITY OF RHINELANDER, COUNTY OF ONEIDA, STATE OF WISCONSIN, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING AT AN IRON MARKING THE NORTHWEST CORNER OF LOT 7, BLOCK 26, ORIGINAL PLAT AND THE PLACE OF BEGINNING OF THE PARCEL TO BE DESCRIBED; THENCE SOUTHERLY ALONG THE WEST LINE OF BLOCK 26 A DISTANCE OF 205.23 FEET TO AN IRON MARKER; THENCE EASTERLY AT AN ANGLE FROM NORTH TO EAST OF 90-00-40 A DISTANCE OF 150.00 FEET TO AN IRON MARKER; THENCE NORTHERLY AT AN ANGLE FROM WEST TO NORTH OF 89-59-20 A DISTANCE OF 108.12 FEET TO AN IRON MARKER; THENCE WESTERLY AT AN ANGLE FROM SOUTH TO WEST OF 90-00-40 A DISTANCE OF 40.00 FEET TO AN IRON MARKER; THENCE NORTHERLY AT A CLOCKWISE ANGLE FROM EAST TO NORTH OF 269-59-20 A DISTANCE OF 47.05 FEET TO AN IRON MARKER; THENCE WESTERLY AT AN ANGLE FROM SOUTH TO WEST OF 90-00-40 A DISTANCE OF 10.00 FEET TO AN IRON MARKER; THENCE NORTHERLY AT A CLOCKWISE ANGLE FROM EAST TO NORTH OF 269-59-20 A DISTANCE OF 50.06 FEET TO AN IRON MARKER (NOW BEING A CHISEL CROSS SET IN CONCRETE), MARKING THE INTERSECTION WITH THE NORTH LINE OF LOT 7; THENCE WESTERLY ALONG THE NORTH LINE OF LOT 7 A DISTANCE OF 100.00 FEET TO AN IRON MARKER, THE PLACE OF BEGINNING. SAID PARCEL CONTAINS 26,400 SQUARE FEET (0.61 ACRES) OF LAND MORE OR LESS.
