Said parcel located in Government Lot's 3 & 4 of Section 33, Township 39 North, Range 7 East, Town of Woodruff, Oneida County Wisconsin; more particularly described as follows;


Commencing at the North One Quarter Corner of said Section 33, thence South 00 degrees 52 minutes 20 seconds East a distance of 2603.43 feet to a 2 inch iron pipe marking the center of said Section 33; thence North 88 degrees 54 minutes 09 seconds East a distance of 72.05 feet to a 1-3/4 inch iron pipe the point of beginning of said attachment parcel; thence South 27 degrees 13 minutes 36 seconds West a distance of 151.80 feet to a 1-1/2 inch iron pipe; thence South 00 degrees 46 minutes 37 seconds East a distance of 77.49 feet to a 2 inch iron pipe; thence South 26 degrees 53 minutes 03 seconds West a distance of 170.20 feet to a 2 inch iron pipe; thence South 27 degrees 15 minutes 59 seconds West a distance of 224.59 feet to a 2 inch iron pipe; thence South 27 degrees 52 minutes 37 seconds West a distance of 24.74 feet to a 2 inch iron pipe; thence North 80 degrees 57 minutes 07 seconds West a distance of 39 58 feet to a 1 inch X 48 inch iron pipe; thence North 25 degrees 43 minutes 03 seconds East a distance of 642.85 feet to a Linch X 48 inch iron pipe; thence North 88 degrees 54 minutes 09 seconds East a distance of 19.95 feet to a 1-3/4 inch iron pipe the point of beginning.
