MADELINE LAKE CONDOMINIUM

A parcel of land in Government Lot 4, Section 5, Township 39 North, Range 7 East, Woodruff Township, Oneida County, Wisconsin, being the "Madeline Lake Condominium" Parcel shown on Map No. 91-133 by Wilderness Surveying, Inc, dated July 7th, 1992, more particularly described as follows:

Commencing at the southwest corner of Government Lot 4, being the corner common to Section 5,6,7 and 8, marked by a brass capped Iron pipe; thence North 89 degrees 32 minutes 22 seconds East for a distance of 1166.46 feet along the south line of Government Lot 4 to an Iron pipe near the westerly shore of Madeline Lake; thence meandering along said lake North 04 degrees 52 minutes 51 seconds West for a distance of 640.35 feet; North 48 degrees 18 minutes 53 seconds East for a distance of 598.23 feet and North 25 degrees 12 minutes 04 seconds East for a stance of 45.72 feet to the place of beginning, marked by an Iron pipe.
