

SURVEYORS'S CERTIFICATE

I, John H. Fisher, registered land surveyor, hereb/ certify:

That in full compliance with the provisions of Chapter 236 of the Wisconsin Statutes and the subdivision regulations of the Town of Minocqua, and under the direction of Keith W. Turner, owner of said land, I have surveyed, divided and mapped SQUIRREL POINT; that such plat correctly represents all exterior boundaries and the subdivision of the land surveyed, being a parcel of land in Gov't. Lot 2, Section 8, T39N, R5E, Oneida County, Wisconsin, more particularly described as follows:

Commencing at the northeast corner of Section 8, marked by a 2" iron pipe with a brass cap, witnessed by a Tamarack Stump bearing S2°E, 9.8 feet; thence S34°-21'W, (solar bearing) 4106.84 feet to the place of beginning, marked by an iron pipe near the shore of Squirrel Lake.

Thence meandering along the lake, N84°-18'W, 60.00 feet; N79°-41'W, 100.00 feet; N50°-44'W, 180.00 feet; N73°-01'W, 100.00 feet; N43°-12'W, 100.00 feet and N9°-26'W, 50.00 feet; thence N81°-45'E, 240.30 feet; thence along the arc of a curve concave southeasterly whose chord bears N53°-30'E, 61.77 feet; thence N42°-57'E, 241.55 feet; thence S4°-03'E, 90.24 feet; thence S1°-29'E, 447.50 feet to the place of
