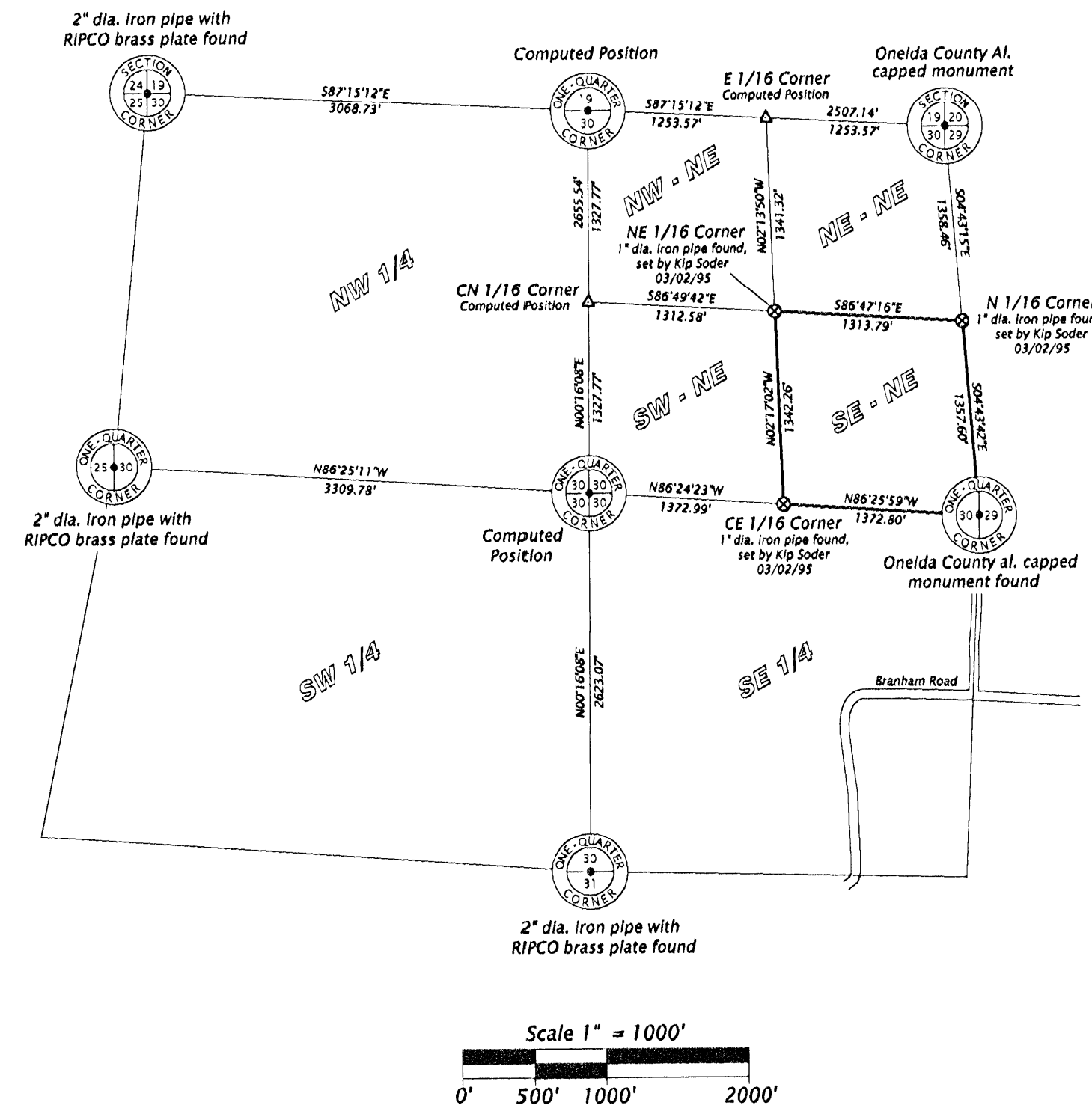

Kip W. Soder, RLS 1731 shows an easement for ingress and egress over this road per Vol. 695, Pg. 426 on his survey dated 3/2/1995 and on his survey dated 7/20/2007. This document describes an easement over an existing road in the NW-SW, SW-NW & NW-NW, Section 29 and the NE-SE & NE-NE, Section 30. The document does not state that the easement lies within the SE-NE of Section 30 nor did the grantor of the easement own the SE-NE of Section 30 at the time the easement was created.

Lot 1

A parcel of land shown as Lot 1 on Favorite Anderson & Maines Surveying, S.C. Map No. 2007038B dated 06/18/2010, being part of the SE 1/4 of the NE 1/4, Section 30, Township 38 North, Range 11 East, Three Lakes Township, Oneida County, Wisconsin more particularly described as follows:

Commencing at the East 1/4 corner of said Section 30 marked by an Oneida County aluminum monument; thence along the section line, N04°43'42"W for a distance of 858.92 feet to an iron pipe; the PLACE OF BEGINNING. Thence N86°47'16"W for a distance of 1335.13 feet to an iron pipe on the west line of said SE 1/4 of the NE 1/4; thence along said west line, N02°17'02"W for a distance of 495.61 feet to the Northeast 1/16 corner marked by an iron pipe; thence along the north line of said SE 1/4 of the NE 1/4, S86°47'16"E for a distance of 1313.79 feet to the North 1/16 corner, marked by an iron pipe; thence along the east line of said SE 1/4 of the NE 1/4, S04°43'42"E for a distance of 498.11 feet to the PLACE OF BEGINNING.

Proposed Easement C

A 32.00 foot wide easement for ingress, egress and utilities shown as Proposed Easement C on Favorite Anderson & Maines Surveying, S.C. Map No. 2007038B dated 06/18/2010, being part of the SE 1/4 of the NE 1/4, Section 30, Township 38 North, Range 11 East, Three Lakes Township, Oneida County, Wisconsin. The centerline of said easement is described as follows:

Commencing at the East 1/4 corner of said Section 30 marked by an Oneida County aluminum monument; thence along the south line of said SE 1/4 of the NE 1/4, N88°25'59"W for a distance of 88.09 feet to the PLACE OF BEGINNING. Thence N57°35'28"W for a distance of 33.17 feet; thence N05°28'02"W for a distance of 111.35 feet; thence N02°45'13"E for a distance of 283.01 feet; thence N09°48'50"E for a distance of 189.85 feet; thence N01°53'45"E for a distance of 192.08 feet; thence N04°43'42"W for a distance of 101.69 feet to the south line of Lot 1 as shown on said Favorite Anderson & Maines Surveying, S.C. Map No. 2007038B dated 06/18/2010, and there TERMINATING. The sidelines of the said easement are extended or foreshortened to terminate on the south line of said SE 1/4 of the NE 1/4 and the south line of said Lot 1.

Proposed Easement A

A 30.00 foot wide easement for ingress, egress and utilities shown as Proposed Easement A on Favorite Anderson & Maines Surveying, S.C. Map No. 2007038B dated 06/18/2010, being part of the NE 1/4 of the SE 1/4, Section 30, and part of the NW 1/4 of the SW 1/4, Section 29, all in Township 38 North, Range 11 East, Three Lakes Township, Oneida County, Wisconsin. The centerline of said easement is described as follows:

BEGINNING at the East 1/4 corner of said Section 30 marked by an Oneida County aluminum monument; thence along the section line S02°24'52"W for a distance of 1255.62 feet to the South 1/16 corner marked by an iron pipe and there TERMINATING. The east line of said easement is extended or foreshortened to terminate on the north and south lines of said NW 1/4 of the SW 1/4, Section 29 and the west line of said easement is extended or foreshortened to terminate on the north and south lines of said NE 1/4 of the SE 1/4, Section 30.

Proposed Easement B

A 30.00 foot wide easement for ingress, egress and utilities shown as Proposed Easement B on Favorite Anderson & Maines Surveying, S.C. Map No. 2007038B dated 06/18/2010, being part of the NE 1/4 of the SE 1/4, Section 30, and part of the NW 1/4 of the SW 1/4, Section 29, all in Township 38 North, Range 11 East, Three Lakes Township, Oneida County, Wisconsin. The centerline of said easement is described as follows:

Commencing at the East 1/4 corner of said Section 30 marked by an Oneida County aluminum monument; thence along the east line of said NE 1/4 of the SE 1/4, S02°24'52"W for a distance of 49.07 feet to the PLACE OF BEGINNING. Thence N57°35'28"W for a distance of 101.70 feet to the north line of said NE 1/4 of the SE 1/4 and there TERMINATING. The sidelines of the said easement are extended or foreshortened to terminate on the north and east lines of said NE 1/4 of the SE 1/4.

Proposed Easement D

A 32.00 foot wide easement for ingress, egress and utilities shown as Proposed Easement D on Favorite Anderson & Maines Surveying, S.C. Map No. 2007038B dated 06/18/2010, being part of the SE 1/4 of the NE 1/4, Section 30, Township 38 North, Range 11 East, Three Lakes Township, Oneida County, Wisconsin. The centerline of said easement is described as follows:

Commencing at the East 1/4 corner of said Section 30 marked by an Oneida County aluminum monument; thence along the south line of said SE 1/4 of the NE 1/4, N88°25'59"W for a distance of 174.19 feet to the PLACE OF BEGINNING. Thence N03°34'01"E for a distance of 18.00 feet; thence S86°25'59"E for a distance of 57.13 feet to the centerline of Proposed Easement C as shown on Favorite Anderson & Maines Surveying, S.C. Map No. 2007038B dated 06/18/2010, and there TERMINATING. The sidelines of the said easement are extended or foreshortened to terminate on the south line of said SE 1/4 of the NE 1/4 and the centerline of said Proposed Easement C.

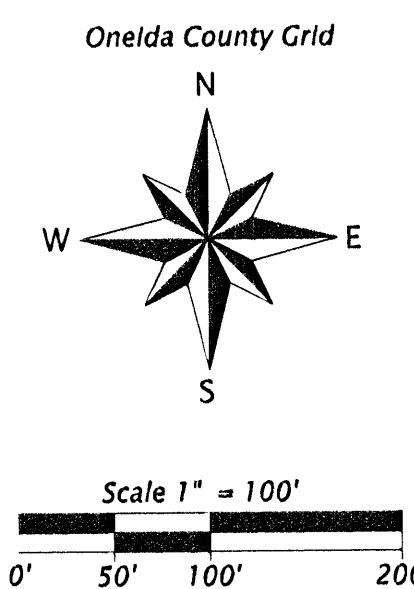
