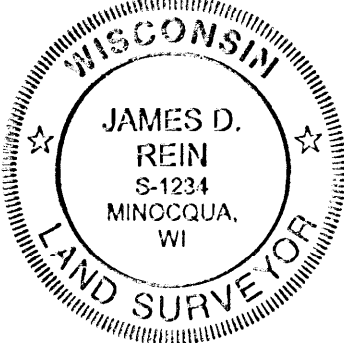

PARK PARCEL (10-77)

A parcel of land located in Government Lot 1, Section 3, Township 38 North, Range 7 East, Town of Lake Tomahawk, Oneida County, Wisconsin, being the "Park Parcel" shown of Map No. 10-77 by Wilderness Surveying, Inc., dated August 17, 2010, more particularly described as follows:

Commencing at the quarter corner common to Section 3 and Section 34, marked by a square concrete monument with brass tablet; thence North 89 degrees 46 minutes 02 seconds East for a distance of 1323.11 feet along the north line of Section 3 to the East Sixteenth Corner, marked by a brass capped iron pipe; thence South 01 degrees 00 minutes 07 seconds East for a distance of 786.16 feet along the east line of Government Lot 1 to an iron pipe at the northeasterly corner of that parcel of land recorded on Document No. 287664; thence North 89 degrees 58 minutes 57 seconds West for a distance of 30.11 feet along the northerly line of that parcel of land recorded on Document No. 287664 to the place of beginning, marked by an iron rod at the southeasterly corner of that parcel of land recorded on Document No. 477215.

Thence continuing along the northerly line of that parcel of land recorded on Document No. 287664, North 89 degrees 35 minutes 14 seconds West for a distance of 150.70 feet, and North 68 degrees 44 minutes 05 seconds West for a distance of 82.31 feet to an iron pipe at the southwesterly corner of that parcel of land recorded on Document No. 477215, also being the southeasterly corner of that parcel of land recorded on Document No. 312419; thence North 00 degrees 54 minutes 19 seconds West for a distance of 35.81 feet along the line common to said parcels of land recorded in Document No. 477215 and Document No. 312419 to an iron pipe; thence South 73 degrees 40 minutes 54 seconds East for a distance of 237.53 feet to the place of beginning.

Subject to a non-exclusive access easement, for the benefit of grantor's remaining property, over a portion of the above described parcel of land, said easement is more particularly described as follows:

Commencing at the quarter corner common to Section 3 and Section 34, marked by a square concrete monument with brass tablet; thence North 89 degrees 46 minutes 02 seconds East for a distance of 1323.11 feet along the north line of Section 3 to the East Sixteenth Corner, marked by a brass capped iron pipe; thence South 01 degrees 00 minutes 07 seconds East for a distance of 786.16 feet along the east line of Government Lot 1 to an iron pipe at the northeasterly corner of that parcel of land recorded on Document No. 287664; thence North 89 degrees 58 minutes 57 seconds West for a distance of 30.11 feet along the northerly line of that parcel of land recorded on Document No. 287664 to the place of beginning, marked by an iron rod at the southeasterly corner of that parcel of land recorded on Document No. 477215.

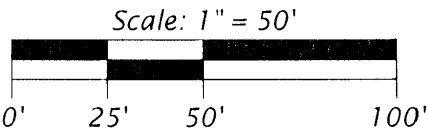
Thence continuing along the northerly line of that parcel of land recorded on Document No. 287664, North 89 degrees 35 minutes 14 seconds West for a distance of 150.70 feet; thence North 83 degrees 43 minutes 12 seconds West for a distance of 40.12 feet; thence North 72 degrees 50 minutes 15 seconds West for a distance of 61.65 feet; thence North 63 degrees 15 minutes 48 seconds West for a distance of 38.98 feet; thence North 43 degrees 35 minutes 10 seconds West for a distance of 26.93 feet to the northerly line of the above described parcel of land; thence South 73 degrees 40 minutes 54 seconds East for a distance of 213.56 feet along the northerly line of the above described parcel of land to the place of beginning.

Together with and subject to covenants, easements, and restrictions of record.

Said property contains 0.14 acres.

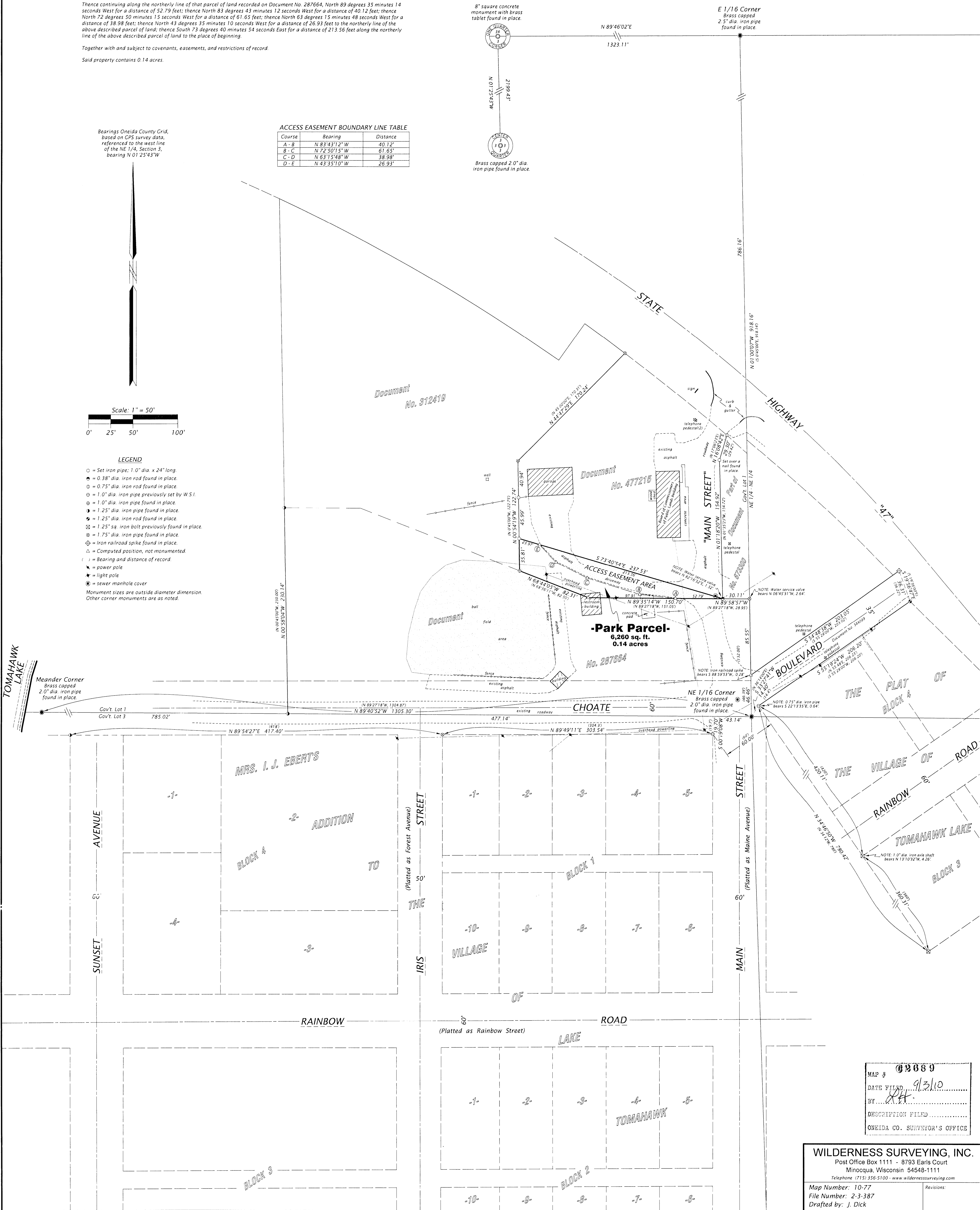
