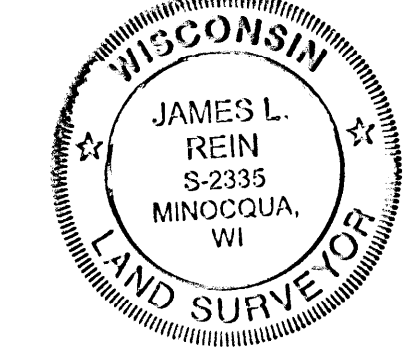

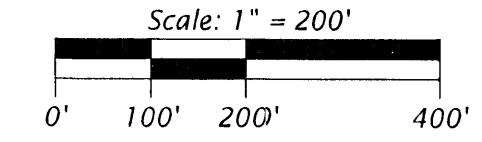

PARCEL -A- (Map No. 08-134division)

A parcel of land located in the Southwest Quarter of the Southwest Quarter and the Southeast Quarter of the Southwest Quarter, Section 25, and also in the Northwest Quarter of the Northwest Quarter, the Northwest Quarter of the Northwest Quarter, the Southeast Quarter of the Northwest Quarter, and the Southwest Quarter of the Northwest Quarter, Section 36, Township 37 North, Range 6 East, Town of Cassian, Oneida County, Wisconsin, being "Parcel A-" shown on Map No. 08-134division, dated September 23rd, 2008, more particularly described as follows:

Commencing at the section corner common to Sections 25, 26, 35, & 36, marked by a Oneida County capped aluminum monument, thence North 00 degrees 21 minutes 46 seconds West for a distance of 423.05 feet along the west line of Section 25 to the place of beginning, marked by an iron pipe on the easterly right of way line of Mitchell Lane.

Thence continuing North 00 degrees 21 minutes 46 seconds West for a distance of 226.75 feet to an iron pipe on the easterly right of way line of Mitchell Lane; thence along a curve to the right, having a radius of 234.00 feet and an arc length of 93.65 feet, being subtended by a chord of North 30 degrees 46 minutes 14 seconds East for a distance of 93.03 feet, along the easterly right of way line of Mitchell Lane to an iron pipe; thence continuing along the easterly right of way line of Mitchell Lane, North 42 degrees 14 minutes 11 seconds East for a distance of 301.69 feet to an iron pipe at the southwesterly corner of that parcel of land recorded in Volume 512 on page 260; thence North 89 degrees 09 minutes 09 seconds East for a distance of 548.36 feet along the southerly line of that parcel of land recorded in Volume 512 on page 260 to an iron pipe at the southwesterly corner of Lot 3 on Oneida County Certified Survey Map No. 2248; thence North 89 degrees 11 minutes 54 seconds East for a distance of 262.97 feet along the southerly line of said Lot 3 to an iron pipe at the southwesterly corner of Lot 4 on Oneida County Certified Survey Map No. 2248; thence North 89 degrees 12 minutes 03 seconds East for a distance of 249.94 feet along the southerly line of said Lot 4 to an iron pipe at the southeasterly corner of said Lot 4; thence North 00 degrees 16 minutes 37 seconds West for a distance of 372.24 feet along the easterly line of said Lot 4 to the Southwest Sixteenth Corner, marked by an iron pipe on the southerly right of way line of Fernwood Road; thence North 89 degrees 08 minutes 05 seconds East for a distance of 802.63 feet along the southerly right of way line of Fernwood Road to an iron pipe at the northwesterly corner of that parcel of land recorded in Document No. 562546; thence South 00 degrees 18 minutes 56 seconds East for a distance of 145.01 feet along the westerly line of said parcel of land recorded in Document No. 562546 to an iron pipe; thence continuing along the westerly line of said parcel of land recorded in Document No. 562546, South 89 degrees 08 minutes 05 seconds West for a distance of 150.01 feet to an iron pipe; thence continuing along the westerly line of said parcel of land recorded in Document No. 562546, South 00 degrees 18 minutes 56 seconds East for a distance of 372.24 feet along the easterly line of said parcel of land recorded in Document No. 562546, North 89 degrees 08 minutes 05 seconds East for a distance of 150.01 feet to an iron pipe; thence continuing along the easterly line of said parcel of land recorded in Document No. 562546, North 00 degrees 18 minutes 56 seconds West for a distance of 66.00 feet to an iron pipe at the southwesterly corner of that parcel of land recorded in Document No. 655676; thence North 89 degrees 08 minutes 05 seconds East for a distance of 290.01 feet along the southerly line of that parcel of land recorded in Document No. 655676 to an iron pipe on the east line of the Southwest Quarter of the Southwest Quarter, Section 25; thence South 00 degrees 18 minutes 56 seconds East for a distance of 988.97 feet along the east line of the Southwest Quarter of the Southwest Quarter, Section 25 to the quarter corner common to Section 25 and Section 36, marked by an Oneida County capped aluminum monument; thence South 00 degrees 08 minutes 50 seconds West for a distance of 1800.96 feet along the east line of the Northwest Quarter, Section 36, to an iron pipe; thence South 89 degrees 28 minutes 45 seconds West for a distance of 979.23 feet to an iron pipe; thence South 00 degrees 30 minutes 02 seconds West for a distance of 800.08 feet to an iron pipe on the northerly right of way line of Meadowlark Road; thence South 89 degrees 28 minutes 45 seconds West for a distance of 337.51 feet along the northerly right of way line of Meadowlark Road to an iron pipe; thence continuing along the northerly right of way line of Meadowlark Road, South 89 degrees 24 minutes 24 seconds West for a distance of 643.66 feet to an iron pipe at the southwesterly corner of Lot 1 on Oneida County Certified Survey Map No. 2250; thence North 00 degrees 14 minutes 02 seconds East for a distance of 656.80 feet along the easterly line of said Lot 1 to an iron pipe at the northeasterly corner of said Lot 1; thence North 89 degrees 45 minutes 35 seconds West for a distance of 600.51 feet along the northerly line of said Lot 1 to an iron pipe on the easterly right of way line Mitchell Lane; thence North 00 degrees 14 minutes 02 seconds East for a distance of 52.20 feet along the easterly right of way line Mitchell Lane to an iron pipe; thence continuing along said easterly right of way line, North 01 degrees 16 minutes 16 seconds West for a distance of 414.43 feet to an iron pipe on the west line of the Northwest Quarter, Section 36; thence North 00 degrees 29 minutes 43 seconds East for a distance of 443.25 feet along the west line of the Northwest Quarter, Section 36, to an iron pipe at the easterly right of way line of Mitchell Lane; thence along a curve to the right, having a radius of 217.00 feet and an arc length of 65.36 feet, being subtended by a chord of North 20 degrees 55 minutes 38 seconds East for a distance of 65.12 feet, along said easterly right of way line to an iron pipe; thence continuing along said easterly right of way line, North 29 degrees 33 minutes 43 seconds East for a distance of 130.15 feet to an iron pipe; thence continuing along said easterly right of way line, along a curve to the left, having a radius of 566.00 feet and an arc length of 487.07 feet, being subtended by a chord of North 04 degrees 54 minutes 23 seconds East for a distance of 472.18 feet to an iron pipe; thence continuing along said easterly right of way line, North 19 degrees 44 minutes 37 seconds West for a distance of 371.89 feet to the place of beginning.
