Beginning at the Southeast Corner of Section 27, marked by an aluminum monument; thence \$86°59'41"W, a distance of 1393.03 feet to the East Sixteenth Corner, marked by a rebar; thence N02°08'06"W, a distance of 1403.13 feet to the Southeast Sixteenth Corner, marked by an iron pipe, said corner being the point of termination of said line.

Subject to easements and restrictions of record and of use.

Beginning at the South Quarter Corner of Section 26, marked by an aluminum monument; thence N89°58'46'W, a distance of 1358.74 feet to the West Sixteenth Corner; thence N01°46'58'W, along the West line of the Southeast Quarter of the Southwest Quarter, a distance of 1190.94 feet to a rebar; thence N89°56'09'E, a distance of 680.16 feet to an iron pipe; thence N01°46'58'W, a distance of 232.45 feet to the North line of the Southeast Quarter of the Southwest Quarter, marked by an iron pipe; thence N89°53'45'E, along said North line, a distance of 697.91 feet to the Center-South Sixteenth Corner, marked by an iron pipe; thence along the East line of the Southeast Quarter of the Southwest Quarter \$01°00'12'E, a distance of 1425.43 feet to the place of beginning.

Subject to the rights of the public over that portion of the above described parcel lying within the right of way of Mark Road and the right of way of C.T.H. "G".




