

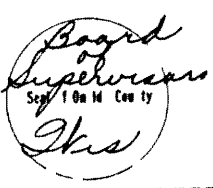
Know all Men by these Presents, That the County of Oneida in the State of Wisconsin by

party of the first part has in and to the following described real estate situated in the County of Oneida in the State of Wisconsin to wit

(Except a strip of land 100 feet wide on each side of the center line of the highway now crossing the above description, together with the timber rights on the said 200 foot strip)

This conveyance does not prevent the trees which be cut or removed from the land shown on the plat to be used for a period of ten years from the date of this deed for the purpose of building a highway or for the purpose of building a dam or for the purpose of building a bridge or for the purpose of building a structure of any kind upon the land shown on the plat. And if the trees are cut or removed for any of the above purposes the title to the land shown on the plat shall remain in effect and the title to the land shown on the plat shall not be affected by the provisions of this deed.
