That there is annexed hereto "Surveyors Certificate" dated
September 22, 1943, relative to the 1/4 Section Corner between
Sections 9 and 10, Township 37 North, Range 7 East, Oneida County,
Wisconsin, which Certificate was made by both of the affiants and which
Certificate is by reference and adoption made a part hereof to the
same force and effect as if incorporated herein at length.

That this affidavit is made as evidence of the facts herein

contained and so that the same may be recorded.

Then follows Surveyors Certificate, dated Sept. 22, 1943, signed by Harry C. Hall and Keith M. Hall, and recites as follows:

We, Harry C. Hall and Keith M. Hall, both competent surveyors of over 40 years and 18 years experience respectively, hereby certify, that we have, on July 20, 1943, visited the 1/4 Section Corner between Sections 9 and 10 Township 37 North, Range 7 East, Oneida County, Wisconsin, and are satisfied that the present position of the Iron Pipe is the position of the original 1/4 Corner set by Government Survey. While it is acknowledged that this corner sets at an unusual position in the Section it is not a singular instance, as We know of many other valid cases of similar distortion.

Though the original U. S. bearing trees have rotted away, the position of each is very evident by the deep impressions in the ground - with each containing remnants of rotted birch wood. These positions agree very favorably with D. H. Vaughans' efforts to preserve and perpetuate this corner. Evidence of his work is still plainly visible in the field and acknowledgement of his findings available not only on the Recorded Plat on Page 19 of Vol. 3, recorded April 22, 1912 in Register of Deeds Office, but also in D. H. Vaughan's County Survey Record (Vault of County Clerk) of Section 9 Township 37 North, Range 7 East, Page 86 States his findings as follows:

alive and his figures (Iron Marks) plain though partly overgrown. His South East tree is rotted and fallen but its base and position is very clear and traces of its Iron Marks are still visible on the burned facing. His stake is also laving nearby - having rotted and fallen.

In Vaughan's work We find one discrepancy between the actual positions of things as set in the field and as it is recorded, and that is; that 46 links recorded is actually 36 links measured in the field. Has to be in order to have the 10 links from the South East tree come in on the correct bearing. The error of an even 10 links in reading the tape is an easily understood possibility, consequently We do not feel that this technicality is of sufficient reason or excuse for any Surveyor to ignore this corner.

This affidavit is made evidence of the fact it contains and entitled to record by Section 2238a of the Wisconsin Statutes and recites as follows:

Ira E. Smith, being first duly sworn, on oath says that he has been a resident of the Town of Cassian, Oneida County, Wisconsin, for more than 38 years last past, and that he is familiar with the facts hereinafter stated; that during the year 1908, he was assessor for the Town of Cassian during that year, having possession of the original Government field notes, he ran a line between Sections 9 and 10 in Township 37 North, Range 7 East, and that he then found the original Government corner and the original Government bearing trees between those two sections; that two years thereafter D. H. Vaughan, then the County surveyor of Oneida County, also ran said section line and said D. H. Vaughan likewise found the original corners in accordance with the Government placement which findings said D. H. Vaughan has recorded in the Oneida County records; that affiant knows that said notes recorded by D. H. Vaughan correspond to the actual corners as known to exist, by affiant.
