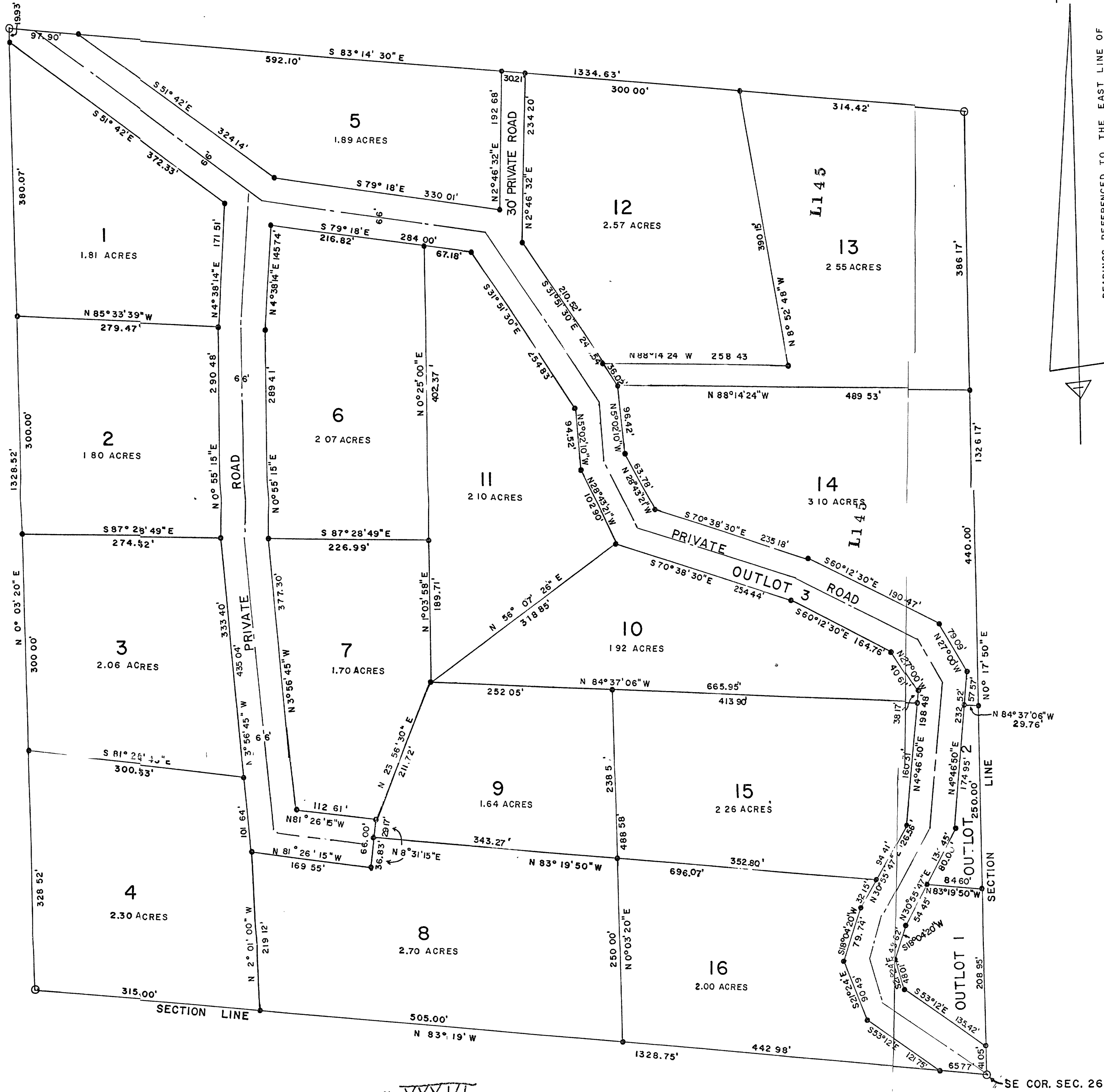

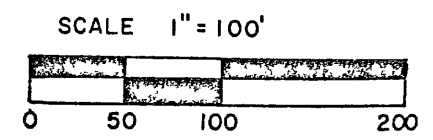
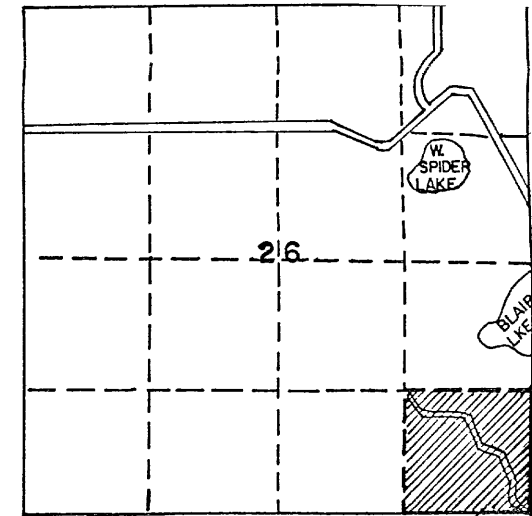

### SURVEYORS CERTIFICATE

I, J. C. Kirby, Registered Wisconsin Land Surveyor No. 500553, do hereby certify:

That in full compliance with the provisions of Chapter 236 of the Wisconsin Statutes and the subdivision regulations of the Town of Newbold, and the direction of Robert H. Truman and Janice Truman, owners of said lands, I have surveyed, divided and mapped the Flat of ONEIDA COUNTY PLAT OF TIMBER RANCH ESTATES; that such Plat correctly represents all exterior boundaries and the subdivision of the land surveyed being the SE 1/4-SE 1/4 of Section 26, Township 38 North, Range 8 East of the Fourth Principal Meridian, Oneida County, Wisconsin, bounded and described as follows:

The point of beginning being an iron pipe marking the Southeast corner of Section 26; thence N. 0° 17' 50" E. along the East line of Section 26 a distance of 1,326.17 feet to an iron pipe, thence N. 85° 14' 00" W. a distance of 1,534.83 feet to an iron pipe; thence S. 0° 03' 50" W. along the West line of the SE 1/4-SE 1/4 of Section 26 a distance of 1,326.17 feet to an iron pipe.
