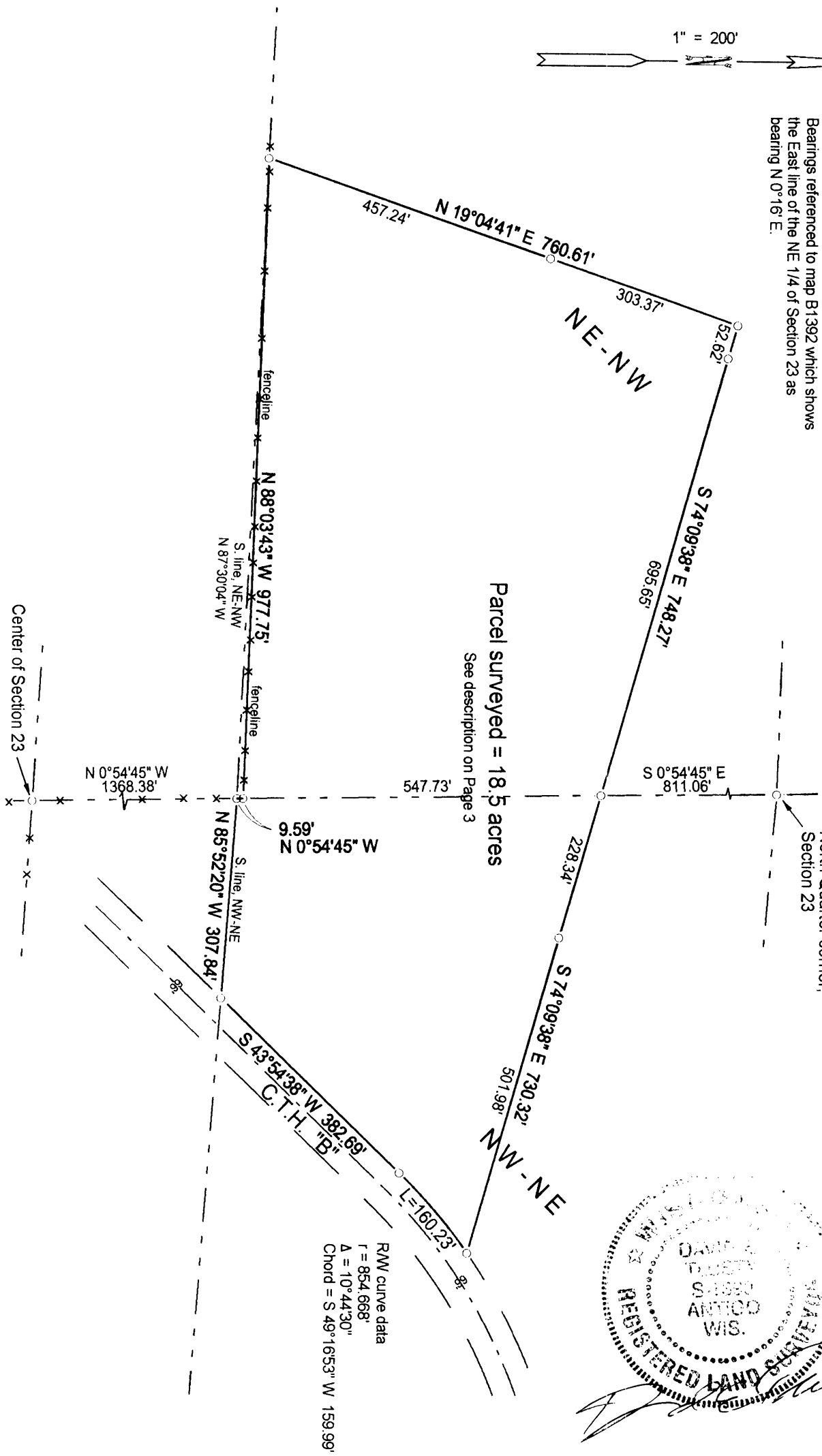
Map of survey for Marv Theilman.

DESCRIPTION OF PARCEL SURVEYED

Part of the Northeast Quarter of the Northwest Quarter (NE-NW) and part of the Northwest Quarter of the Northeast Quarter (NW-NE) of Section 23, T. 35 N., R. 11 E., Oneida County, Wisconsin, more particularly described as follows:

Commencing at the North Quarter corner of said Section 23; thence S 0°54'45" E, along the North-South quarter line of said Section 23, 811.06 feet to the point of beginning, being an iron pipe; thence S 74°09'38" E, 730.32 feet to an iron pipe on the North line of C.T.H. "B"; thence southwesterly along said North line, 160.23 feet along the arc of a 854.668' radius curve, concave to the southeast, having a chord of S 49°16'53" W, 159.99 feet to an iron pipe; thence S 43°54'38" W, continuing along the North line of C.T.H. "B", 382.69 feet to an iron pipe; thence N 85°52'20" W, along the South line of said NW-NE, 307.84 feet to an iron pipe at the SW corner of said NW-NE; thence N 0°54'45" W, along the North-South quarter line, 9.59 feet to an iron pipe at a fence corner; thence N88°03'43"W, along an existing fenceline, 977.75 feet to an iron pipe on the South line of said NE-NW; thence N 19°04'41" E, 760.61 feet to an iron pipe; thence S 74°09'38" E, 748.27 feet to the point of beginning, said parcel containing 18.5 acres.

Said parcel is subject to exceptions, reservations, restrictions and easements, if any, in use or of record.
