Bearings Solar

A parcel of land in the NE1/4 of the SW1/4, NW1/4 of the SE1/4, SE1/4 of the SW1/4 and the SW1/4 of the SE1/4, Section 34, T39N, R6E, Minocqua Township, Oneida County, Wisconsin, more particularly described as follows:

Commencing at the one-quarter corner common to Sections 3 and 34, marked by a 1" iron pipe, witnessed by a 12" Norway Pine bearing N55°W, 19.5 feet and a 9" Oak bearing S2°W, 14.5 feet; thence N5°24'15"W (solar bearings) 1113.51 feet to the place of beginning.  
 Thence N44°43'29"W, 227.86 feet; thence 65.91 feet along the arc of a curve concave southwesterly, with a radius of 83.00 feet, the chord of which bears N67°28'24"W, 64.19 feet; thence S89°46'40"W, 360.74 feet; thence 247.22 feet along the arc of a curve concave southeasterly with a radius of 242.77 feet, the chord of which bears S60°36'22"W, 236.68 feet; thence 66.62 feet along the arc of a curve concave northwesterly with a radius of 74.40 feet, the chord of which bears S57°05'05"W, 64.41 feet; thence S82°44'06"W, 3.11 feet; thence N12°39'16"W, 177.31 feet; thence S89°53'54"E, 843.74'; thence N1°54'04"W, 461.50 feet; thence N88°05'56"E, 100.00 feet; thence N1°54'04"W, 215.92 feet; thence S71°38'25"E, 460.93 feet; thence S33°58'46"W, 544.66 feet; thence 335.77 feet along the arc of a curve concave southeasterly with a radius of 2964.93 feet, the chord of which bears S30°44'06"W, 335.59 feet to the place of beginning.

Subject to any easements, restrictions or rights of way of record or of use, and to a perpetual easement for public utilities.
