
PARCEL "B" LEGAL DESCRIPTION:

A parcel of land being part of NE.1/4 of the SE.1/4 of Section 33 and part of the NW.1/4 of the SW.1/4 of Section 34, T.38 N., R.8 E., Town of Newbold, Oneida County, Wisconsin, and being more particularly described as follows:

Commencing at the W.1/4 corner of said Section 34; thence S.33°26'04"W., 100.71 feet; thence S.74°50'31"W., 415.31 feet to the point of beginning of parcel to be described; thence S.26°46'30"E., 272.12 feet; thence S.58°47'26"E., 710.00 feet to a meander point, on the westerly shore of the Fredrick Flowage; thence S.71°12'36"W., along a meander line, 670.40 feet to a meander point near said westerly shore; thence N.26°27'00"W., 770.00 feet; thence N.60°59'45"E., 283.34 feet to the point of beginning. Said parcel includes that land lying between said meander line and the normal high water line of the Fredrick Flowage and the lateral extension of the above described lands.

Said parcel contains 10.01 acres, more or less and having the benefit of a 33' wide driveway easement for ingress and egress over the existing road as now traveled. Said easement road located in the NW.1/4 of the SW.1/4 and in Government Lot 5 of Section 26, in the SE.1/4 of the SE.1/4 of Section 27, in Government Lot 1, the SE.1/4 of the NE.1/4, the SW.1/4 of the NE.1/4, the SW.1/4 of the NW.1/4, the SW.1/4 of the NW.1/4, the SE.1/4 of the NW.1/4 and the NW.1/4 of the SW.1/4 of Section 34, and in the NE.1/4 of the SE.1/4 of Section 33, all in said T.38 N., R.8 E.

Commencing at the W.1/4 corner of said Section 34; thence S.33°26'04"W., 100.71 feet to the point of beginning of parcel to be described; thence S.79°43'25"E., 416.00 feet to a meander point, on the westerly shore of the Fredrick Flowage; thence S.7°05'56"W., along a meander line, 650.22 feet to a meander point near said westerly shore; thence N.58°47'26"W., 710.00 feet; thence N.26°46'30"W., 272.12 feet; thence N.74°50'31"E., 415.31 feet to the point of beginning. Said parcel includes that land lying between said meander line and the normal high water line of the Fredrick Flowage and the lateral extension of the above described lands.

Said parcel contains 10.03 acres, more or less and having the benefit of a 33' wide driveway easement for ingress and egress over the existing road as now traveled.
