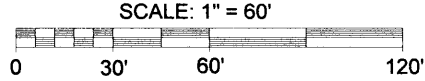

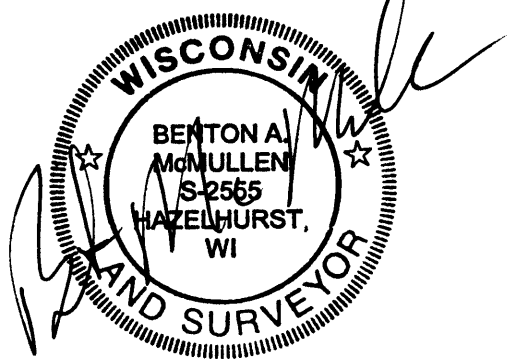
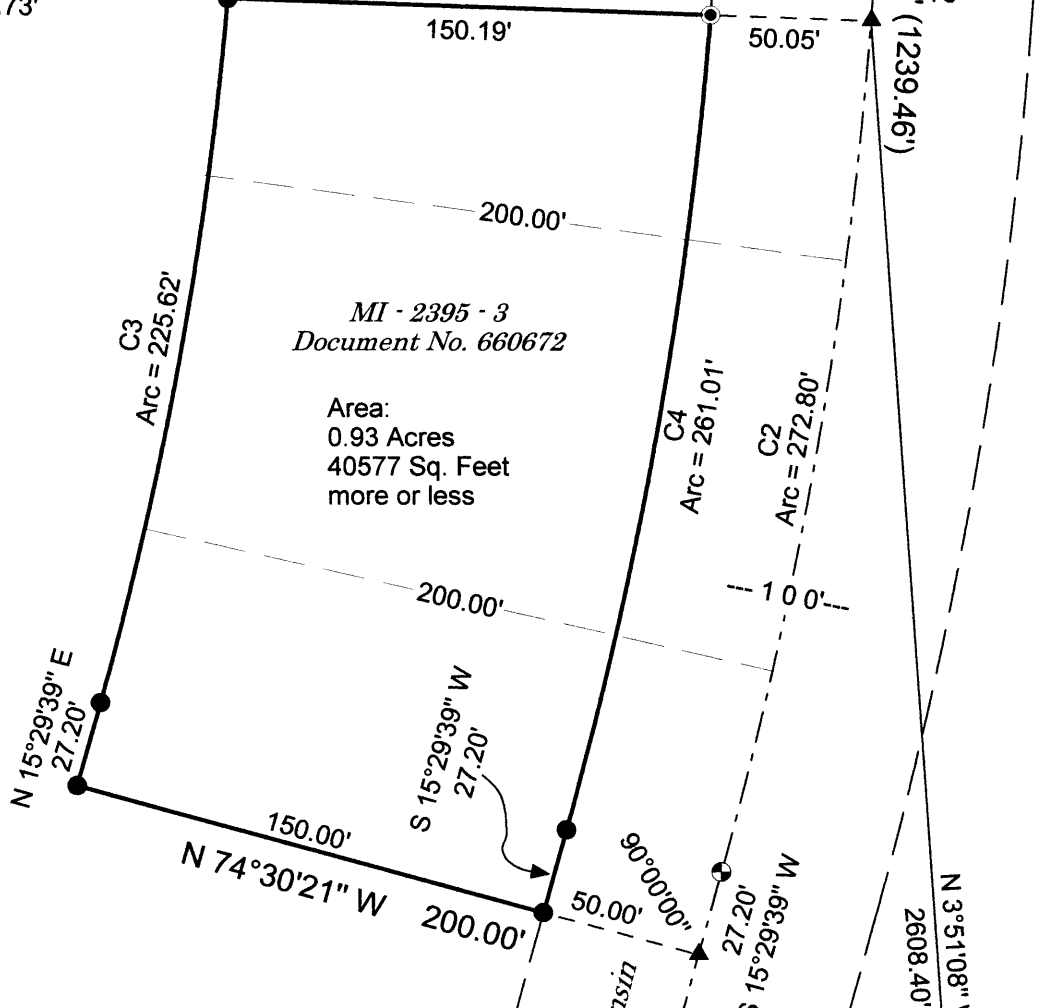

Description

Part of the Northeast 1/4 of the Southwest 1/4, Section 27, Township 39 North, Range 6 East, town of Minocqua, Oneida County, Wisconsin shown on a survey map by McMullen & Associates, Incorporated of Minocqua, Wisconsin dated the 9th Day of April, 2009 with a Job No. of 209025, previously described in Document No. 660672 recorded at the Oneida County Register of Deeds Office and more particularly described as follows:

Commencing at the South 1/4 corner of said Section Marked by a 1" Iron Pipe; thence North 3° 51' 08" West (Assumed North, based on the East - West 1/4 line of said Section which bears South 88° 01' 12" East), a distance of 2608.40 feet to a point at the intersection of said 1/4 line and the centerline of the State of Wisconsin D.N.R. Bearskin Trail; thence along the Centerline of said Bearskin Trail a distance of 272.80 feet along the arc of a curve to the right having a radius of 1432.78 feet, a delta angle of 10° 54' 33" and a long chord 272.39 feet in length which bears South 10° 02' 22" West, to an Aluminum Monument; thence continuing along said centerline South 15° 29' 39" West, a distance of 27.20 feet to a point; thence leaving said centerline North 74° 30' 21" West being a right angle to said centerline, a distance of 50.00 feet to a 1 3/4" Iron Pipe on the Westerly right-of-way of said Bearskin Trail, said point being the POINT OF BEGINNING.

Thence continuing Westerly along said bearing (North 74° 30' 21" West), a distance of 150.00 feet to a 1 3/4" Iron Pipe; thence North 15° 29' 39" East and parallel to said centerline, a distance of 27.20 feet to a 1 3/4" Iron Pipe; thence continuing parallel to said centerline along the arc of a curve to the left a distance of 225.62 feet, having a radius of 1232.78 feet, a delta angle of 10° 29' 11" and a long chord which bears North 10° 15' 03" East, having a length of 225.31 feet to a 1 3/4" Iron Pipe on the East - West 1/4 Line of said Section; thence South 88° 01' 12" East along said 1/4 line, a distance of 150.19 feet to a 1 3/4" Iron Pipe on the Westerly right-of-way of said Bearskin Trail; thence leaving said 1/4 line along said right-of-way along the arc of a curve to the right a distance of 261.01 feet having a radius of 1382.78 feet, a delta angle of 10° 48' 54" and a long chord 260.62 feet in length which bears South 10° 05' 12" West, to a 1 3/4" Iron Pipe; thence continuing along said right-of-way South 15° 29' 39" West, a distance of 27.20 feet to the POINT OF BEGINNING.

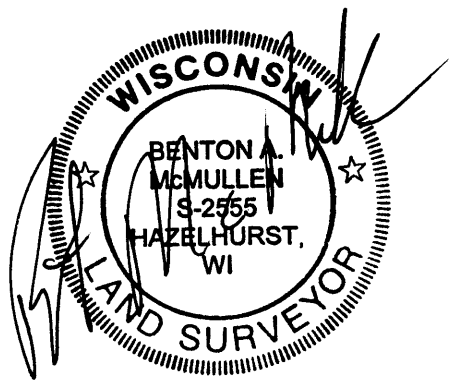
